1. Karnataka Power Corporation Limited invites bids through GOK e-procurement platform for Operation & Maintenance of 3 MW Grid Connected Solar PV Plant at Yopaladinni village in Raichur District, Karnataka state, for a period of 2(Two) years and extendable by one more year.
2. **Detailed Scope of work**
  - i) Operation and Maintenance of all equipments installed at 3 MW Grid Connected Solar plant.
  - ii) Maintenance of foundation structures of all equipments, existing garden etc.
  - iii) Cleaning of power house.
  - iv) Cleaning of array yard regularly.
  - v) Module cleaning with pressurized water as per schedule.
  - vi) Minor repairs and allied civil maintenance works.

The tender can be downloaded in the portal as per prescribed date and time published in the portal. Only interested contractors who wish to participate should remit on line transaction fee for tender after registering in the portal. The transaction fee is nonrefundable.

**Earnest Money Deposit:**

**EMD: Rs.1,24,250/-** (Rupees One Lakh Twenty Four Thousand Two hundred and Fifty only). The e-payment shall be made (direct debit, credit card & National Electronic Fund Transfer (NEFT) or Over The Counter (OTC) only through ICICI Bank.

The EMD shall be valid for a period of 180 days from the date of opening of the technical bid. In case, the validity of the Bid is required to be extended, the validity of the EMD shall be extended up to 30 days beyond such extended bid validity period. Part and incomplete bid/ bids not accompanied with EMD / belated bids will not be accepted.

Eligible bidders shall submit Tenders electronically (online through internet) within the date and time published in e-procurement portal. Cover-2 of Tender will be opened at prescribed time and date in the e-procurement portal, in the presence of the bidders who wish to attend at the office of the Executive Engineer (Solar), KPCL, # 3, Green Building, First Floor, Palace Road, Bengaluru - 560 001.

**7. MINIMUM QUALIFYING REQUIREMENTS:**

- i. The intending Bidder should have successfully carried out at least 1 (one) similar work of Operation & Maintenance of Solar PV plant as Prime Contractor of value not less than Rs.32.00lakhs (single order) in Central/State Govt./PSU's and/or reputed organizations in any one of the previous five financial years i.e., 2018-19, 2017-18, 2016-17, 2015-16 and 2014-15. Work order and corresponding work done certificate/ satisfactory performance certificate shall be uploaded as a documentary proof.
- ii. The bidder in his name should have achieved in at least two financial years an average annual financial turnover of Rs.63.00lakhs in the last five financial year's i.e., 2018-19, 2017-18, 2016-17, 2015-16 and 2014-15. Annual report, turn over certificate, copy of Auditor's Report along with the Balance Sheets, Trading and Profit & Loss statements and other financial statements shall be uploaded as a documentary proof duly certified by charted accountant.
- iii. The intending bidder shall have the Income tax PAN, GST Registration, ESI registration certificate, Provident Fund registration certificate (Independent PF Code). Copies shall be uploaded as documentary proof.
- iv. The intended bidder shall hold a valid class-I and above Electrical contractor license. As a proof of the same, the bidder shall furnish a valid class-I and above Electrical contractor license issued by competitive authority. Copy shall be uploaded as documentary proof.

**8. The tender is of two cover system**

The Bidder should upload scanned copies of the following documents.

**COVER – I (Technical bid)**

- a. Earnest Money Deposit (EMD).
- b. Bidder shall upload ANNEXURES 1, 4 & 5 as mentioned in bid document duly signed with stamp.
- c. Pre qualifying requirement documents.

## **COVER-II (Price Bid)**

- a. Price schedule only.
- 9. Bids submitted within the scheduled date and time shall only be eligible for further processing of the bids. Any bid submitted after the date and time specified shall be rejected even if it is accepted by the e-portal. Date and time stamp of the e-portal system shall be final in deciding the time of submission of bid. Decision of the Corporation in this regard shall be final and acceptable to all the bidders.
- 10. The original documents should be produced for verification at any stage of tender process as and when sought for, failing which, the bids are liable for disqualification.
- 11. Price Schedule document shall be uploaded in e-procurement portal only in the space provided for uploading “Financial Bid documents”.
- 12. Price bid of bidders who have furnished all documents to meet the qualification criteria, technically and commercially responsive offer will only be opened.
- 13. The tender shall be valid for 180 days from the date of opening of Cover-1 of the bid.
- 14. The bidders shall visit the 3MW Grid Connected Solar PV Plant at Yapaladinni village to understand the system before submitting the tenders.
- 15. The tender document is part and parcel of the agreement.
- 16. Conditional Tenders will not be accepted.
- 17. The Bidders should furnish a scanned copy the latest Income Tax returns.
- 18. The agency whose contract has been cancelled or fore-closed by KPCL or by any Govt. organizations in the last 5 years due to un-satisfactory performance are not eligible for participating in this tender. To this effect a declaration is to be made by the bidders.
- 19. The agency who receives the Work Orders from KPCL and thereafter if Work is not executed / not satisfactorily executed by them due to any reasons mentioned thereafter are not eligible for applying/participating in this tender.
- 20. KPCL reserves the right to verify any information/documents furnished by the bidder should the circumstances so warrant. In case the information or the document furnished is found to be incorrect / false or invalid then the EMD furnished by such bidder shall be forfeited.
- 21. Right to reject any or all the bids without assigning any reasons rests with the accepting authority.
- 22. Bidder shall upload / furnish the ANNEXURES 1, 4 & 5 duly signed with stamp.
- 23. The contractor shall obtain insurance coverage for all the workers working in this area.
- 24. The contractor shall quote his rates inclusive of GST & other charges, PF, ESI as per the applicable rates as issued by the concerned departments from time to time.
- 25. KPCL shall recover the Income Tax, GST etc., at the prevailing applicable rates.
- 26. The bidder should maintain the register of labour deployed and the wages paid for the workers and shall produce the documents whenever called for by the competent authority. The remittance towards PF shall commensurate with the labour component for the work involved.

27. Contractor should have independent PF code and ESI registration certificate. The contractor shall remit PF & ESI of labours to contractor's permanent PF code number & ESI registration certificate only and not to the KPCL PF sub-code”.
28. KPCL shall monitor the attendance of deployed staff/workers at plant through biometric system. The installation of biometric system shall be in KPCL scope.
29. If the contractor makes any alterations in the conditions of the contracts or puts any condition of his own, such tenders are liable for rejections.
