- 1.0 The Chief Engineer (Electrical Designs) invites bids from the qualified bidders for the "Supply, installation & Commissioning of Solar PV Modules, 10KVA Inverter Panel & 100AH Solar Batteries for off grid 10kW roof top system including buy back of existing old Batteries" at 3MW Solar Plant, Yalesandra, Kolar district. Pre-qualification criteria & bid documents may be downloaded from Government of Karnataka e-procurement website https://eproc.karnataka.gov.in under login for contractors.
- 2.0 After login to Contractors, please scroll down to the right side bottom to see list of tenders, please click there to find the details of NIT & download copy of the tender. The tender can be downloaded from the portal as per prescribed date & time published in the portal. Only interested Contractors who wish to participate should remit on line transaction fee for tender after registering in the portal. The transaction fee is non-refundable.

3.0 BRIEF SCOPE OF WORK:

"Supply, installation & Commissioning of Solar PV Modules, 10KVA Inverter Panel & 100AH Solar Batteries for off grid 10kW roof top system including buy back of existing old Batteries" at 3 MW Solar PV Plant, Yalesandra, Kolar district"

Scope of the work given is only indicative. Detailed scope has been described in the bid document, which is binding on all the bidders.

4.0 EARNEST MONEY DEPOSIT (EMD)

- An Earnest Money Deposit for an amount of Rs 11,800/-(Rupees Eleven thousand Eight Hundred only) as indicated in the Notice inviting bids and/ or Brief bid notification shall accompany each bid as detailed in following paragraphs:
- 4.01. Earnest Money Deposit of Rs. 11,800/-(Rupees Eleven thousand Eight Hundred only) shall be paid online trough e-Procurement portal using any of the following payment modes:
 - a. Credit Card,
 - b. Direct Debit,
 - c. National Electronic Fund Transfer (NEFT),
 - d. Over the Counter (OTC) (only through designated branches of ICICI Bank).
- 4.02. Bids not accompanied by the requisite EMD shall be summarily rejected.
- 4.03. If the bidder withdraws his bid before the expiry of the bid validity period prescribed in the bid specification or if the successful bidder fails to submit the contract performance guarantee as specified in the bid & or fail to enter into a contract with the Corporation in the form prescribed with related requirement within 30 days of the date of letter of award, the bid guarantee will be forfeited as liquidated damages.
- 4.04. The EMD furnished by unsuccessful bidders will be returned, only after the award of contract & entering in to agreement with the successful bidder.
- 4.05. For the successful bidder, the EMD will be returned, only after he enters into contract agreement & furnishes the contract performance guarantee (Security Deposit) in an acceptable form.
- 4.06. No interest is payable to the bidders for the Earnest Money Deposit.
- 4.07. The bidder shall quote in Indian rupees only.

7.0 Eligibility Criteria:

- 7.01. The intending bidder shall satisfy the pre-qualification requirements as stipulated below:
 - a. Bidder should have successfully carried out the work of Supply, Installation, Commissioning of minimum of 5kW & above roof top Solar System & above to any one no. of factories/Power plants/industries in India & the same shall be in satisfactory operation continuously for a minimum period of 1 year during the preceding 5 years from the date of issue of NIT with total Order/Orders value not less than 2.36 Lakhs. Satisfactory completion certificate & performance certificate issued from competent authority/State/Central Government undertaking/any utility from officers not below the rank of Executive Engineer/ equivalent cadre/Project head shall

be furnished. Copy of the work order for corresponding works shall be furnished.

b. Bidder shall have achieved average annual turnover of Rs 4.72 Lakhs in any of the two financial years during last five financial years. As proof of the above, the audited balance sheet, Profit & loss account counter signed by Chartered accountant shall be furnished.

Note: The intending bidder shall furnish the documentary evidence to substantiate the qualification requirement specified.

- 7.02. The intending bidder shall furnish the following documentary evidence to substantiate the qualification requirement specified above for the fulfilment.
 - i) Satisfactory completion certificate is to be furnished to satisfy the condition in 7.01(a) above. Satisfactory completion certificate signed by an officer of the rank of Chief Engineer or Station Superintendent/Competent Authority of respective plant/industry/factory.
 - ii) Bidder during the last five financial year period shall have achieved average annual turnover of Rs 4.72 Lakhs in any of the two financial years during last five financial years. As proof of the above, the audited balance sheet counter signed by Chartered accountant shall be furnished to satisfy the condition in 7.01(b) above.
- 7.03. Those bidders whose EMDs are forfeited/contracts have been terminated/foreclosed by KPCL or elsewhere or whose performance has not been found satisfactory while executing contracts with KPCL or elsewhere during the last 03 years are not eligible to bid. The Bidder shall give declaration that EMD has not been forfeited & none of his contracts have been terminated /foreclosed on account of their default in KPCL or elsewhere during the last 03 years.
- **8.0** Bidder shall not be under declaration of ineligibility for corrupt & fraudulent practices issued by the Government of Karnataka.
- 9.0 The tender is of two cover system.
 The Bidder should upload scanned copies of the following documents:

A. COVER-I (Technical Bid)

- a) Documents to meet the qualification criteria specified in NIT.
- b) The notarized declaration by the bidder that none of his contracts have been subject to forfeiture of EMD/foreclosure/ termination of

their Contract in KPCL/Government or any other utility & blacklisted for participating in tender by KPCL or Government or any other utility in India during the past ten years (Refer schedule-9).

c) Details of the Commercial terms & conditions, all the schedules specified in bid documents pertaining to commercial terms & conditions. All the technical details & drawings etc., of the technical offer along with all the technical particulars.

B. COVER-II (Price Bid)

Price schedule only (Price Bid).

- 10.0 Bids submitted within the scheduled date & time shall only be eligible for further processing of the bids. Any bid submitted after the date & time specified shall be rejected even if it is accepted by the e-portal. Date & time stamp of the e-portal system shall be final in deciding the time of submission of bid. Decision of the Corporation in this regard shall be final & acceptable to all the bidders.
- 11.0 The original documents should be produced for verification at any stage of tender process as and when sought for, failing which, the bids are liable for disqualification.
- 12.0 Rates shall be quoted in price schedule in the e-procurement portal only in the space provided for uploading "FINANCIAL BID DOCUMENTS". The bidder shall quote the final price in price bid considering the buy back
- 13.0 Price bid of tenderers who have furnished all the documents to meet the qualification criteria, technically & commercially responsive will only be opened.
- 14.0 The tender shall be valid for 180 days from the date of opening of 'Cover-I' of the bid.
- 15.0 KPCL reserves the right to verify any information/documents furnished by the bidder. In case the information or the documents furnished are found to be incorrect/false or invalid, then the EMD furnished by such bidder shall be forfeited.
- 16.0 Corporation reserves the Right to reject any or all the tenders without assigning any reasons. However, in all cases, KTPP act shall be followed.

- 17.0 Any other information required may be obtained from the office of the undersigned during office hours.
- 18.0 Bidders who have not obtained the user ID & Password for participating in e-procurement in Karnataka Power Corporation Limited may now obtain the same from the website (https:/eproc.karnataka.gov.in).
