INTRODUCTION

Increasing emission of greenhouse gases in the atmosphere is a global concern. Stabilization of greenhouse gas concentration in the atmosphere at a level that would prevent dangerous anthropogenic interference with the climate system has become global objective. In this context in the year 1992, the "United Nations Framework Convention on Climate Change" (UNFCCC) was signed by over 150 nations. The climate convention was the base for the international co-operation with in the climate change area and India was one of the signatory of the same. Thereafter various protocols were prepared and agreed by signatory nations. Subsequent to this, in 2008, Govt. of India formulated National Action Plan on Climate Change (NAPCC) for integrated strategy for achieving key goals for climate change. On the basis of recommendation of NAPCC under the renewable energy technology program, Government of India has come out with Acts, policies and regulations to support renewable energy.

MEDA has been accorded the responsibility to install of solar steam cooking system in order to get efficient cooking arrangement for feeding the food to 1000 visitors/persons per day at the Temple. The project is proposed to be established on available land plot in Ma Jagdamba Tample, Koradi (MJT) to cater to the needs of Temple at Koradi, Nagpur. The project is envisaged to be set up as 'Captive Grid Connected' power plant owned by MJT Koradi.



SECTION – 1: INSTRUCTIONS TO BIDDER

1. GENERAL INSTRUCTIONS

- 1.1 The Bidder is advised to read carefully all instructions and conditions appearing in this document and understand them fully. All information required as per the bid document must be furnished and the Annexure contained herein should be duly filled in. Failure to provide the information as required may render the bid technically unacceptable. The bid shall be submitted in English Language only.
- 1.2 The bidder in quoting his rate shall for all purpose, whatsoever, be deemed to have himself independently obtained all relevant and necessary information for the purpose of preparing his bid document. The bidder is required to satisfy himself in all respect, before the submission of offer.
- 1.3. The bidder shall be deemed to have examined the bid document, to have obtained his own information in all matters whatsoever that might affect the carrying out of the works at the schedules rates and to have satisfied himself to the sufficiency of his bid. Any error in description or quantity or omission in the Contract Document shall not vitiate the contract or release the Bidder from executing the work comprised in the contract according to drawings and specifications at the scheduled rates. He is deemed to know the scope, nature and magnitude of the works and requirement of materials, equipment, tools and labour involved, wage structures and as to what all works he has to complete in accordance with the contract documents irrespective of any defect, omissions or errors that may be found in the contract documents. - 1.6. The bid document submitted shall be the property of the Implementing Agency.
- 1.7. The Bidder must visit the site at his cost and take first hand information related to the contract and access the actual quantity of work involved, site conditions and all other aspects of the site before submission of offer.

- 1.8. The Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents. Failure to furnish all information required by the Bidding documents or submission of a bid not substantially responsive to the Bidding Documents in every respect will be at the Bidder's risk and may result in rejection of his bid.

- 1.15. Bidder shall be required to submit Earnest Money Deposit (EMD) of Rs. 75000 (Rupees seventy five thousand Only) **should be paid online through respective portal.** No Interest will be payable on EMD. In absence of EMD the bid will be rejected.
- 1.16. Forfeiting of EMD- The EMD paid or submitted by the Successful Bidder shall be forfeited if:
 - o In any case if the bidder withdraws his tender before finalization of work order.
 - o The Successful Bidder does not accept work order/LOI within stipulated period assigned.
 - The Successful Bidder violates any of the provisions of the terms and conditions of this tender.
 - o The Successful Bidder fails to deposit requisite Security deposit.
 - The Successful Bidder fails / refuses to execute the order as herein, the bidder shall be deemed to have abandoned the contract & such an act shall amount to and be construed as the bidders calculated and wilful breach of contract, the cost and consequence of which shall be to the sole account of the bidder and in such an event the MEDA shall have full right to claim damages thereof in addition to the forfeiture of EMD.

1.17. Security Deposit

 The Successful Bidder shall furnish Security deposit at *3% of the total project cost as per date mentioned in Letter of Intent by demand draft of any nationalized bank in favor of Maharashtra Energy Development Agency, Nagpur.

*Additional Security Deposit (SD) clause:-

- If bidder quotes within the limit of -20% to +10% of the tender estimated cost, the Security Deposit (SD) of 3% of contract value is to be deposited.
- If bidder quotes below 20%, then bidder has to submit Security Deposit (SD) as mandatory 3% + additional percent with respect to percentage below 20% of the total contract value. For ex. If Bidder quotes -24% then bidder has to submit 3% mandatory + 4% additional = 7% of the total contract value as security deposit (SD).
- Failure to comply with the terms of security deposit shall result into cancellation of work order without any further reference to the Successful Bidder and the EMD shall be forfeited.
- The security deposit shall be liable to be forfeited wholly or partly at the sole discretion of the MEDA, if the Successful Bidder either fails to execute the work of above projects or fails to fulfil the contractual obligations or fails to settle in full his dues to the MEDA.
- In case of premature termination of the contract, the SD will be forfeited and the MEDA will be at liberty to recover the loss suffered by it & if additional cost is to be paid, the same shall be recovered from the Successful Bidder.

- 1.20. The joint venture for said project are not allowed.
- 1.21. EMD of unsuccessful Bidders will be returned after awarding of contract.
- 1.21.1 The EMD of a successful bidder will be retained till the deposit of security deposit and returned after submission of security deposit on request application of agency.

2.1. Bidder should have Experience of installation and commissioning of solar cooking system for 1500 person within last 5 years ending last day of the previous month.). The experience certificate duly signed by officer of concern department is mandatory to attached along with copy work order.

2.2. Bidder should have minimum 1 Crore positive Net Worth/Turnover of last financial year(enclose details.....)..

3. DEADLINE FOR SUBMISSION OF OFFERS

3.1. Bids must be received by Divisional General Manager, Maharashtra Energy Development Agency (MEDA), Divisional Office, Nagpur 1st Floor, Milk Scheme Society, G.P.O. Chowk, Civil Lines, Nagpur- 440 001. on or before the date and time specified in the Notice Inviting Tender / this bid document.

4. LATE OFFERS

4.1. The Bids received after the deadline for submission of offers shall be rejected. Implementing agency is not responsible for any delay or non submission of Bids within time limit due to internet issues etc.

5. LANGUAGE OF OFFER

5.1. The language of the Bid prepared by the Bidder, as well all correspondence and documents relating to the bid exchanged by the Bidder and the Implementing agency, shall be English language only.

6. VALIDITY OF OFFER

- 6.1. The offer shall remain valid for a period of 180 days from date of opening of the bid.
- 6.2. The bid and the prices schedule included shall remain valid for a period of 180 days initially from the date of opening of the bid within which period the Bidder shall have no right to withdraw, revoke or cancel his offer or unilaterally vary the offer submitted or any terms thereof. In case of the Bidder revoking or canceling his offer or varying any term in regard thereof, MEDA shall forfeit the earnest money paid by him along with the offer. Offer may however be revised or revalidated for extended period as required by implementing agency in writing.

7. SIGNING OF OFFER

7.1. The offer should be signed by the authorized signatory and sealed by the Successful Bidder. The necessary power of attorney required for authorized signatory should be enclosed with the offer. The offer shall contain no erasures or overwriting except as necessary to correct errors made by the Bidder. Such corrections, if any, shall be initialed by the person(s) signing the offer.

- 9.2. The amendments will be notified in writing or by fax / email to all prospective Bidders, who have purchased the bid document and will be binding on them. Implementing agency will bear no responsibility or liability arising out of non-receipt of the same in time or otherwise.

10. COST OF BIDDING

10.1 The Bidder shall bear all cost associated with the preparation and submission of its bid, and Implementing agency will in no case be responsible or liable for these costs, regardless of the conduct or outcome of the process.

11. PROCEDURE FOR OPENING OF BIDS

- 11.1. Qualifying Requirements and Technical Offer shall be opened at the time, date and address mentioned in the NIT, in the presence of Bidders who wish to be present during opening of bid.
- 11.2. Bids for which a notice of withdrawal has been submitted shall not be opened.
- 11.3. Bids that are not opened and read out at bid opening shall not be considered for further evaluation, irrespective of the circumstances.
- 11.4. If any information furnished by the Bidder is found to be incomplete, or contained in formats other than those specified herein, the Implementing agency may, in his sole discretion, exclude the relevant document from computation of the eligible score of the Bidder.
- 11.5. The technical bids shall be evaluated by the Implementing agency for assessing responsiveness, Bidder's qualification and technical capability confirmation. The Bidders whose technical bids are declared as technically responsive and qualified shall be informed accordingly and their Price bids shall be opened.
- 11.6. The Bidders whose technical bids do not qualify, their Price Bids shall not be opened.
- 11.7. Price Bid opening date shall be conveyed in writing by fax or e-mail.
- 11.8. 12. CONFIDENTIALITY

concerned with the process or is not a retained professional advisor advising the Implementing agency in relation to or matters arising out of or concerning the Bidding Process. The Implementing agency will treat all information, submitted as part of Bid, in confidence and will require all those who have access to such material to treat the same in confidence. The Implementing agency may not divulge any such information unless it is directed to do so by any statutory entity that has the power under law to require its disclosure or is to enforce or assert any right or privilege of the statutory entity and/ or the Implementing agency or as may be required by law or in connection with any legal process.

13. TESTS OF RESPONSIVENESS

17.1. The Implementing agency reserves the right to accept or reject any bid and to annul the bidding process and reject all bids at any time prior to award of Contract, without thereby incurring any liability to the affected Bidder or Bidder's or any obligation to inform the affected Bidder or Bidder's.

18. FRAUD AND CORRUPT PRACTICES

- 18.1. The Bidders and their respective officers, employees, agents and advisers shall observe the highest standard of ethics during the Bidding Process. Notwithstanding anything to the contrary contained herein, the Implementing agency may reject the Bid without being liable in any manner whatsoever to the Bidder if it determines that the Bidder has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice in the Bidding Process.
- 18.2. Without prejudice to the rights of the Implementing agency, if the Bidder is found by the Implementing agency to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice during the Bidding Process, such Bidder shall not be eligible to participate in any tender or Bid issued by the Implementing agency during a period of 2 (two) years from the date such Bidder is found by the Implementing agency to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice, as the case may be.



SECTION – 2: COMMERCIAL CONDITIONS OF CONTRACT

1. **DEFINITIONS**

- **1.1.** Commercial Conditions of Contract shall be read in conjunction with General Conditions of the Contract, Scope of Work, Deliverables and any other document forming part of this contract wherever the contract so requires.
- **1.2.** Notwithstanding the subdivision of the document into these separate sections and volumes, every part of each shall be deemed to be supplementary of every other part and shall be read with and into the contract so far as it may be practicable to do so.
- 1.3. Where any portion of the General Conditions of the Contract repugnant to or at variance with any provision of Commercial Conditions of the Contract, then unless a different intention appears, the provision(s) of the Commercial Conditions of Contract shall be deemed to override the provisions of General Conditions of the contract only to the extent that such repugnancies of variations in the Commercial Conditions of the Contract as are not possible of being reconciled with the provisions of General Conditions of Contract.
- **1.4.** The materials, designs and workmanship shall satisfy the applicable relevant Indian & International Standards, the job specifications contained herein & codes referred to. Where the job Specifications stipulate requirements in addition to those contained in the standard codes and specifications, these additional requirements shall also be satisfied.
- **1.5.** The manpower deployed for the project shall be qualified, experienced in the similar field and number of people shall be sufficient to carry out the activities without any delay.

2. SCOPE OF WORK

- 2.1. The Bidder is responsible Design, Engineering, Fabrication, Supply, Transportation, Storage, Insurance, Erection, Testing and Commissioning of Design, Engineering, Fabrication, Supply, Transportation, Storage, Insurance, erection, testing and commissioning of solar steam cooking system for 1000 person per day with 05 year CMC at Shri Mahalaxmi Jagdamba Temple, Koradi, Maharashtra, India.
- **2.2.** The scope of all the work related to installation of solar cooking system...
- **2.3.** The civil construction work
- **2.4.** The scope shall include the following also:
 - All relevant drawing, data sheets, technical catalogues on each piece of equipment / devices and type test certificates.
 - Materials and accessories, which is necessary or useful for satisfactory and trouble-free operation and maintenance of the above equipment.

- Air conditioners along with required accessories for Control room for maintaining specified temperatures in equipment / store / office areas.
- The item of work to be performed on all equipment and accessories shall include but not be limited to the following:
 - i. Transportation, unloading, receiving and storage at site.
 - ii. Arranging to repair and/or re-order all damaged or short-supply items
 - iii. Final check-up of equipment and commissioning and putting the system into successful operation for carrying power from plant to DISCOM which is within the premises of MJT / nearby from the proposed solar Power plant.
- **2.5.** All the approvals, listed below but not limited to, related to solar cooking system at MJT Complex, Koradi are in the scope of Bidder.
 - In order to import any items, associated with the Solar cooking system from abroad or from any other state in India, Contractor shall have to arrange any clearance, permission, if required at his own risk and cost, from any Government (State Government & Central Government) controlled organization for transportation of materials from manufacturing shop to delivery at Site.
 - All necessary approvals require for commissioning of said system is in the scope of bidder.
- **2.6.** The Bidder has to clearly understand the scope of work before quoting the bid & signing of Contract Agreement. Implementing agency will not responsible for any confusion of Bidder regarding Scope of Work. Implementing agency will not release any additional amount in any event after signing of Contract with successful Bidder.

3. CONTRACT AGREEMENT

3.1. The works should be executed as a single contract, inclusive of supply and service portions.

4. OBLIGATIONS OF THE BIDDER

- **4.1.** Subject to and on the terms and conditions of this Agreement, the Bidder shall undertake the survey, investigation, design, engineering, procurement, construction, and maintenance of the Project and observe, fulfill, comply with and perform all its obligations set out in this Agreement or arising hereunder.
- **4.2.** The Bidder shall comply with all Applicable Laws and Applicable Permits (including renewals as required) in the performance of its obligations under this Agreement.
- **4.3.** The Bidder shall discharge its obligations in accordance with Good Industry Practice and as a reasonable and prudent person.

- **4.4.** The Bidder shall remedy any and all loss or damage to the Project from the Appointed Date until the end of the Construction Period at the Bidder's cost, save and except to the extent that any such loss or damage shall have arisen from any default or neglect of the Implementing agency.
- **4.5.** The Bidder shall remedy any and all loss or damage to the Project during the Defects Liability Period at the Bidder's cost to the extent that such loss or damage shall have arisen out of the reasons.
- **4.6.** The Bidder shall remedy any and all loss or damage to the Project during the Maintenance Period at the Bidder's cost save and except to the extent that any such loss or damage shall have arisen on account of any default or neglect of the Implementing agency or on account of a Force Majeure Event.

4.7. Bidder's Personnel

- a. The Bidder shall ensure that the personnel engaged by it or by its Subcontractors in the performance of its obligations under this Agreement are at all times appropriately qualified, skilled and experienced in their respective functions in conformity with Good Industry Practice.
- b. The Implementing agency's Engineer may, for reasons to be specified in writing, direct the Bidder to remove any member of the Bidder's or Subcontractor's personnel. Provided that any such direction issued by the Implementing agency's Engineer shall specify the reasons for the removal of such person.
- c. The Bidder shall on receiving such a direction from the Implementing agency's Engineer order for the removal of such person or persons with immediate effect. It shall be the duty of the Bidder to ensure that such persons are evicted from the Site within 10 (ten) days of any such direction being issued. The Bidder shall further ensure that such persons have no further connection with the Works or Maintenance under this Agreement. The Bidder shall then appoint (or cause to be appointed) a replacement.

4.8. Advertisement on Project

The Project or any part thereof shall not be used in any manner to advertise any commercial product or services.

4.9. Bidder's care of the Works

The Bidder shall bear full risk in and take full responsibility for the care of the Works, and of the Materials, goods and equipment for incorporation therein, from the Appointed Date until the date of Provisional Certificate (with respect to the Works completed prior to the issuance of the Provisional Certificate) and/or Completion Certificate (with respect to the Works referred to in the Punch List), save and except to the extent that any such loss or damage shall have arisen from any default or neglect of the Implementing agency.

4.10. Electricity, water and other services

The Bidder shall be responsible for procuring of all power, water and other services that it may require.

5. SITE PARTICULARS

- **5.1.** The bidder must visit, visualize and clearly understand the Scope of Work the site conditions before submission of price bid at his cost & risk.
- **5.2.** The bidder shall be deemed to have visited the site and familiarized himself thoroughly with the site conditions before submitting the bid. Non familiarity with the site conditions will not be considered as reasons for extra claims or for not carrying out the work in strict conformity with the drawings and specifications.

6. ACCESS FOR INSPECTION

6.1. The Bidder must provide access for inspection at all times during the progress of the works and the maintenance period and the necessary support and adapt as directed for the inspection or measurement of the works by the Site Engineer.

7. COST OF TRANSPORTATION

7.1. The Bidder shall include in his quotation the cost of transportation, unloading, stacking, insurance and storing of all types of materials for their work on the site and at the places approved by the Site Engineer.

8. DRAWINGS

8.1. Drawings accompanying the bid document are indicative of scope of work and issued for bidding purpose only. Purpose of these drawings is to enable the bidder to make an offer in line with the requirements of the Implementing agency. All drawings is as per IEC standard of Gov. and all required approvals to be taken from Concern department/authority is the duty of bidder.

9. TOOLS & TACKLES

9.1. Bidder shall provide at his cost all types of construction equipment, tools, tackles and all such materials required for timely completion of job in all respects to the entire satisfaction of engineer in charge.

10. INSURANCE

10.1. Responsibility of Bidder

- a. The goods supplied under the contract shall be fully insured by Bidder as long as the psystem continues to remain under the custody of the Bidder against the loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in such a manner that Project Implementing agency shall not incur any financial loss.
- b. In case of any loss or damage or pilferage or theft or fire accident or combination of the said incidents etc. under the coverage of insurance, the Bidder shall lodge the claim as per rules of insurance. Any FIR required to be lodged to local Police Station shall be the responsibility of Bidder.

- c. The Bidder shall arrange to supply/rectify/recover the materials even if the claim is unsettled for timely completion of the project. The final financial settlement with the insurance company shall be rested upon the Bidder.
- d. In case of any delay of the project attributable to the Bidder, the Bidder himself in consultation with Project Implementing agency should take the extension of insurance. Any financial implications shall, however, be borne by the Bidder.
- e. The Bidder should arrange for providing insurance coverage to his workmen under Workmen's Compensation Act or similar Rules and Acts as applicable during execution of work for covering risk against any mishap to his workmen. Bidder shall also undertake a Third Party Insurance. Project Implementing agency will not be responsible for any such loss or mishap.
- f. Fire insurance is to be arranged by the Bidder up to the completion of the construction and the commissioning phase of the solar power plant.
- g. In the event of any fire incident occurring in the plant during the O&M period, the Bidder shall lodge the insurance claim on behalf of the Implementing agency and obtain the claim settlement from the insurance company on behalf of the Implementing agency.

11. SAFETY MEASURES

11.1. The Bidder shall have to provide necessary and adequate safety measures including personal protective equipment and precautions to avoid any accident, which may cause damage to any equipment / material or injury to workmen. Project Implementing agency or Owner shall not be responsible for any such accidents.

12. TERMS OF PAYMENT

- Submission of Complete Project Insurance policy documents effective from date of commissioning of the project for period of 5 years covering damage by natural calamities, fire, forceful damage of project, theft, etc.
- System Photograph accompanying MEDA official taken during joint inspection.
- Warranty/Guaranty Certificate of materials used in project.

Comprehensive Maintenance Contract (CMC) document as per clause mentioned in section IV
 "Technical Specification of solar cooking system for 05 years on the letter head of bidder.

MEDA official at their discretion can ask bidder to submit document other than above mentioned, failing to submit the required and above mentioned document, MEDA will have the rights to hold the payment for 70% of total project.

- iv. 1% labour Cess

13. PERFORMANCE TESTS

- **13.1.** Once the system is successfully completed for commissioning and start up and is capable of safe operation in accordance with Prudent Utility Practices and the operating manual, the Bidder shall be entitled to perform a Performance Tests for the plants. The Bidder shall give Project Implementing agency, their representatives at least 15 days prior notice of the date on which Bidder intends to commence any Performance Test for the plants.
- **13.2.** The Implementing agency and their representatives shall be entitled to attend and witness the Performance Tests. For the purpose of demonstration the achievement of the minimum standard required for Provisional Performance Acceptance of the Plants. The Performance Tests shall consists of the operation of the plants for a period of 15 (fifteen) days.
- **13.3.** Each Performance Tests, for whatever purpose, shall also include the confirmation of the electrical system characteristics, overload capacity and minimum stable load and Performance Ratio of the plant.
- 13.4. Bidder shall not attempt to perform any Performance Test, if Implementing agency shall give

notice to Bidder of any aspect of the unit, as applicable, that has not been completed by the Bidder, the completion of which is required for the safe operation of all or any part of the plant, as applicable, during the Performance Test in accordance with Applicable Laws, Applicable Permits, Prudent Utility Practices and the Operating Manual.

13.5. Until Final Performance Acceptance has occurred, Bidder may perform and re-perform additional Performance Tests/Availability Tests, as applicable. Bidder shall keep the Representative continuously apprised of the specific schedule and changes therein, for the commencement and re-performance of Performance Tests. Bidder, at his discretion, may abort any attempted Performance Test.

14. CONTRACT SCHEDULE

The total execution schedule will not exceed 3 months from the date of work order.

15. ARBITRATION

- **15.1.** Except where otherwise provided, if at any time, any question, dispute or difference, whatever shall arise between the Bidder and the Implementing agency upon or in relation to or in connection with this contract either of the parties may give to the other notice in writing of the existence of such a question, on rejection of the matter, the dispute or difference shall be referred to the sole arbitrator jointly appointed by MEDA and the Bidder at the time of dispute after ascertaining the terms of reference mutually.
- **15.2.** The Arbitrator will preferably be a member of Arbitration Council an arbitration proceedings will take place as per provisions of Arbitration and Conciliation Act, 1996 or any statutory modifications or re-enactment thereof, and the rules made there under and for the time being in force shall apply.
- **15.3.** The Bidder will ensure that the work under this contract shall continue during arbitration proceedings and dispute and no payments due from or payment by the Implementing agency shall be withheld on account of such proceedings except to the extent which may be in dispute.

16. COURT OF COMPETENT JURISDICTION

16.1. The Pune Court will have jurisdiction in this case.



Currently food is cooked using traditional direct flame method which leads to high consumption of LPG cylinders.

MINIMUM TECHNICAL SPECIFICATIONS

The solar steam generating system will comprise of automatically tracked parabolic concentrators and balance of system (BOS) for conditioning and utilizing thermal energy in working fluid. The working fluid can be in the form of water, steam and organic or inorganic fluid.

BOS may consist of solar thermal receivers, steam/ hot water/oil pipelines, feed water/oil pumps, tank assemblies, steel structures and civil works, instrumentation like pressure gauges and temperature indicators etc. It will be hooked up with conventional system already in use for specific applications. In case of new systems, fossil fuel based boiler, vessels for cooking/ vapour absorption machine for cooling etc may be provided as the case may be. Minimum technical specifications of various components of the system will be as per below:

1. Concentrators

- **1.** Shape & make of each concentrator: Parabolic shape made of solar grade reflecting mirror(s) fixed to a supporting frame / structure
- 2. Aperture area: 10 sq. m minimum

3. Reflecting mirrors:

- a. Material* :High quality reflective mirrors for outdoor use with protective layers of coating on back surface and sides to protect from exterior weathering effect or any other reflecting material of similar reflectivity and durability.
- Reflectivity: 90% minimum with a maximum degradation of 10% over its life span.
 Warranty/ guaranty to be provided for a period of five years. To be replaced immediately by the supplier if found deteriorating during this period.
- c. Mirror fixing: With positive locking or sticking by industry proven outdoor-rated adhesives. Due protection of reflector coatings be taken while fixing the mirrors.
- **4.** Concentration ratio (Aperture/ Receiver areas) : 120 or above for double axis tracking concentrators

2. Tracking Arrangement:

- a. Any reliable automatic tracking mechanism with motorized reverse in evening & park at morning position including safe position in case of abnormal operating conditions.
- b. Made of standard components; to be protected from rain, dust & outside environment
- c. Tracking accuracy: +/- 0.5 degree (to be ensured using field-calibrated inclinometer)

5. Heat receivers, Headers and piping:

- a. Tested working fluid pressure: 1.5 times of designed pressure
- b. Receivers : Of boiler/standard industry quality to sustain required temperature and pressure
- c. Header material and piping: Designed & manufactured as per IBR/ standard industry quality

6. Insulation:

a. All working fluid piping to be insulated with minimum thickness of 50 mm of PUF or rock wool. Headers or water-steam tank, insulated sides of receiver etc. to have minimum insulation of 75 mm. For colder regions facing sub zero temperatures, minimum thickness will be 100 mm and 150 mm respectively. In such regions cold water pipe lines including valves etc. will also be insulated. Insulation on receivers should withstand a minimum temperature of 600c. All insulated components to have Al sheet or powder coated steel sheet cladding as per industrial practices so as not to allow rain water to sip in the insulation.

7. Frames and Supporting Structures:

Strong enough to avoid any deformation of the reflector dish during manhandling/ tracking/under wind pressure of 180 km per hour. Of mild steel/ any other strong material with epoxy/anti-rust coating

8. Instrumentation & Controls: Complete with all instrumentation such as pressure gauge, temperature indicator, fluid level indicators, safety valves, fluid meter etc. Data acquisition and control system with online monitoring to be installed for automatic monitoring, control and record of all important process parameters in installations above 500 sq. m. of dish area.

9. PERFORMANCE SPECIFICATIONS AND REQUIREMENTS

System should able to generated minimum energy to boil food as mentioned below.

- 1. 200 Kg Rice
- 2. 150 KG Dal
- 3. 150 KG Vegetables

Steam vessels for boiling with LPG boilers shall be provided with complete CST system.

- **10.** All parts/components will be of weather resistant design/specifications to withstand natural weathering outdoors under local climatic conditions, for a minimum period of 15 years. Warranty for a minimum period of 5 years will be provided by the supplier. Necessary spares will also be provided so that the user do not face any problem at least during the warranty period.
 - a. The steel structures provided to support various components of the system will be fabricated in such a way that they are able to take load (both wind load and static dead load) of the whole system. In case the terrace where the system is to be installed is not strong enough to bear the loads, these should be transferred into columns and beams and the proposed load arrangement must be discussed with the concerned civil engineering department and their approval obtained
 - b. The personnel of the buyer/user institution will be trained by the supplier in the operation and maintenance of the system and its back-up system. Proper manuals will be prepared and provided to the user. Log book will also be supplied to the and user so that proper documentation is maintained
 - c. The other important features of system will be
 - i. it will have easy access to the user and proper walkway and platforms will be supplied for easy operation and maintenance of the system wherever necessary
 - ii. safety features such as safety valves etc will be incorporated in the system so that system does not explode under pressure and
 - iii. proper instrumentation as mentioned above will be provided so that user could see the status of system and take precautions

11. OPERATION AND MAINTENANCE MANUAL

An Operation and Maintenance Manual, in English, should be provided with the CST. The Manual should have information about solar energy, parabolic concentrators, and BOS. It should also have clear instructions about running and maintaining the system along with DO's and DONT's.

D) Monitoring of the System:

System will be monitored mainly by manufacturer and Beneficiary Institute. The user also intends to enter it to operation and maintenance contract with the installer after the warrantee period. The sufficient training will be imparted to user for daily monitoring and day to day operation.
