GVK will also submit the draft public notice to the Commission by 03.07.2020 failing which GVK will be liable to action under section 142 of the Electricity Act, 2003.

The petition shall be taken up for hearing on 29.07.2020 at 11.00 AM and both the parties shall complete the pleadings before the next date of hearings.
