INTERIM ORDER

- 1. The case was heard by the Commission on 23.06.2020, as scheduled, through virtual court (Vidyo App).
- 2. The representative of HVPNL Shri Rajesh Goel, SE / HVPNL stated that the issues raised by the Petitioner were discussed in the meetings of the Coordination Committee for Open Access held on 04.06.2020 and 22.06.2020, through video conferencing. The Petitioner as well as Respondents have made their submissions. The hearing is complete and the minutes of the meeting are being finalized.
- 3. Ms. Divya Anand, Ld. Advocate appearing for Respondents nos. 2, 3 and 4 confirmed that they have submitted written reply before the meeting held on 22.06.2020.
- 4. Shri Anand K. Ganeshan, Ld. Advocate for the petitioner argued that the copy of reply submitted by the Respondents has not been made available to them and prayed that an Interim relief may be granted to them by directing HVPNL to grant connectivity to the power plant of the Petitioner so that the capacity of the power plants to generate green power can be utilized and the daily financial loss caused due to loss of green generation can be mitigated.
- 5. On hearing the matter & considering the urgency explained by the Petitioner, the Commission directs HVPNL to issue minutes of meeting of Coordination Committee held on 22.06.2020 with the next 4 working days. Commission will take a view, after taking into consideration the decision taken by the Coordination Committee.
- 6. The next date of hearing shall be communicated separately.
