- 8. The bids shall remain valid for acceptance for a period of 90 (Ninety) Days from the last date of submission of bids.
- 9. Any bidder having criminal record, is not allowed to participate in **e-tender** process.
- 10. The rates should be quoted as per specification, GST will be paid extra as per applicable by Govt. Rules.
- 11. The lowest rate quoted will be analyze by a committee of officers of UPSCIDCO and work order will be issue to the successful bidder subject to acceptability/recommendation of rates by the committee. If bidder is not able to work as per requirement of the site with specified quality, order will be canceled and security will be forfeited.
- 12. Superintending Engineer, UPSCIDCO reserve the right to accept or reject any or all tenders or in part thereof without assigning any reason whatsoever and without any legal obligation thereof. The Decision of the Superintending Engineer will be final and binding to all. UPSCIDCO also reserve the right to increase or decrease the quantity to be ordered.
- 13. Work will be done within limit of the fund amount made available by the concerning department. Work will be done according to the instruction of Executive Engineer. '
- 14. The contractor shall also abide by the provisions of the child labour (Prohibition and Regulation) Act.1986.
- 15. The Contractor shall be completely held responsible for any mishap at site due to in sufficient safety measures.
- 16. In respect of all labour directly or indirectly employed in the works for the performance to the contractor is part of this contract. The contractor shall comply with or cause to the complied with all the rules framed by Government from time to time for the protection of the health and sanitary arrangement for workers employed by the contactor.
- 17. For any type of substandard quality of material/work the suitable deduction will be made from contractor as per direction of Engineer in Charge.
- 18. All the work shall be carried out as per details specification of MNRE/NEDA and as per direction of Engineer In Charge.
- 19. In Case of any damage/loss of UPSCIDCO material etc. the cost of the same shall be deducted from the contractor bill.
- 20. 5% Security will be deducted from each running bill which will be released after six month of handover of work.
- 21. The Successful bidder have to executed an agreement on Rs.100.00 Non Judicial stamp paper.
- 22. The successful bidder will have to submit 5% performance guarantee of the tendered cost in the form of bank guarantee/FDR/DD of nationalized bank in favour of UPSCIDCO, Bareilly.
- 23. UPSCIDCO reserve the right to accept or reject any or all tender or in part thereof without assigning any reason and also reserve the right to increase or decrease the quantity to be ordered.
