KERALA STATE ELECTRICITY BOARD Ltd, invites competitive bids from domestic bidders for bidders for Appointment of Engineering, Procurement and Construction (EPC) Contractor for the design as per site conditions, supply, installation, testing and commissioning of 1.5 MWp Grid tied ground mounted Solar PV plant in the land owned by Kerala State Electricity Board Limited in Nenmara in Palakkad District, Kerala to generate and deliver 1.5 MWp to the grid including Operation and Maintenance of the plant for the first 5 years from the date of commissioning. The performance ratio(AC) shall be as detailed in clause 2.2.3 of this documents Volume I.

Two Lakh towards EMD and the non-refundable tender cost amounting to Rupees Eleven Thousand Eight Hundred only shall be remitted to the account number given in the remittance form provided by the e-procurement system for this particular tender. State Bank of India Multi Option Payment System (SBI MOPS Gateway): Bidders are required to avail Internet Banking Facility for making tender remittances in eProcurementSystem. **Only INTERNET BANKING remittance is allowed.**

No other mode of payment is allowed. (Bidder should ensure that tender cost including GST and EMD are remitted as one single transaction and not separate. **Separate or split remittance will be treated as invalid transactions**). Bidders are advised to visit the **"Downloads"** section of the website www.etenders.kerala.gov.in also. *Bidders, who are using Other Banks option under SBI MOPS Payment Gateway, are advised by SBI to make online payment 72 hours in advance before tender closing time* to ensure that payment towards tender document fee and EMD are credited and a confirmation is reflected in the e-procurement system.

All the Tender documents are to be submitted online only and in the designated covers on the above website and no manual submission will be entertained. The pre-qualification/technical bid shall be opened online at the office of the Chief Engineer (Renewable Energy & Energy Savings), 9th Floor, VidyuthiBhavanam, Pattom, Thiruvananthapuram on the date and time mentioned above in the presence of the bidders/ their representatives who wish to attend. All other existing conditions related to the tenders of KSEB Ltd will be applicable to this tender also. The tender details will also be available in the KSEBL website 'www.kseb.in'.

The bid shall be valid for 180 days reckoned from the date of opening of bid. No queries will be entertained after the pre bid meeting. There will be no negotiation of price once the bid is submitted and the price shall be firm. No correspondence would be made with the bidders once the bid is submitted. The bidder shall visit the site before submitting the bid preferably before the pre bid meeting. The decision taken in the PQ Committee will be final.

The bidding authority reserves the right to modify/cancel any or all bids without assigning any reasons. K.S.E.B. Ltd will not be responsible for any errors like missing of schedule data while downloading by the bidder/ non receipt of document/delay if any.
