ORDER

The petition was taken up for hearing on admission. After hearing the counsel appearing on behalf of PSPCL, the petition is admitted. PEDA has filed an IA for impleading as a respondent, being a necessary party, to the petition. After hearing the counsel for PEDA, IA is allowed.

During hearing, the Commission sought the following information from PSPCL:

1. Category-wise number and total capacity of SPV plants under net metering ending 31.03.2020.

2. Category-wise generation in Mus of SPV plants under net metering as covered in point 1 above.
3. Category wise per unit loss of revenue to PSPCL due to installation of SPV plants under net metering and total loss of revenue due to net metering in FY 2019-20.
4. The benefits accrued to PSPCL due to reduction in distribution loss and RPO compliance on account of installation of SPV plants as covered in point 1 above.
5. Category wise number of applications and total capacity of the pending applications with PSPCL.
6. Projected capacity addition of SPV plants under net metering in next 5 years.

PSPCL shall submit the aforementioned information by 02.09.2020.

PEDA shall file its reply to the petition alongwith the reply to the information submitted by PSPCL by 05.09.2020 with a copy to PSPCL (through hard copy and soft copy). PSPCL may file its rejoinder to the reply filed by PEDA, if any, by 07.09.2020.

The petition shall be taken up for further hearing on 09.09.2020 at 11.00 AM.
