For inviting objections in respect of Petition No. 07 of 2020 & Petition No. 08 of 2020 filed by Punjab Energy Development Agency before the Hon'ble Punjab State Electricity Regulatory Commission under Section 62 of Electricity Act, 2003, Chapter VI of PSERC (Conduct of Business) Regulations, 2005 and PSERC (Terms and Conditions for Determination of Generation, Transmission, Wheeling and Retail Supply Tariff) Regulations, 2014 read with other relevant provisions of the Electricity Act, 2003 with respect to the following:-

- Petition No. 7 of 2020:- Determination of Levellised Feed-in-Tariff for sale of surplus power of grid connected solar pumps of capacity 3, 5 & 7.5 HP under Component-C of Pradhan Mantri Kisan Urja Suraksha evam Utthaan Mahabhiyaan (PM-KUSUM) Scheme.
- Petition No. 8 of 2020: Determination of Levellised Generic Tariff for sale of power of solar power plants of capacity 500KW to 2MW under Component—A of Pradhan Mantri Kisan Urja Suraksha evam Utthaan Mahabhiyaan (PM-KUSUM) Scheme.
 - 1. Notice is hereby given to all that the Punjab Energy Development Agency (PEDA) has filed subject cited Petition No. 07 of 2020 & Petition No. 08 of 2020 for determination of tariff for F.Y 2020-21 as referred above.
 - 2. All the objectors who have filed their objections by the last date for filing of the objections and other persons/ organizations interested in presenting their views/suggestions on the above mentioned matter are invited to participate in the public hearing before the Hon'ble Commission.
