- 2 Bidders must submit attested photocopies of valid G S.T registration Certificate (if any), last three years Income Tax Return, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License from local bodies as the case may be.
- 3 Bidders must submit Credential in similar nature of work during last three years.
- 4 In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
