Notice Inviting Expression of Interest (EOI) for Shortlisting of Suitable Land Banks/Parcels for implementation of Solar Power Project(s).

SJVN Limited intends to develop 500 MW and above (with at least 100 MW at single location) Ultra Mega Renewable Energy Power Project (UMREPP) in the state of Rajasthan.

To develop the project, SJVN Ltd requires cumulative 3000 Acres of Land and invites proposals from prospective Private Land Owners/ Farmers/Co-operative Societies/Land Aggregators etc. willing to Sell on outright basis OR Long Term Lease (28 Years) anywhere across Rajasthan meeting the following criteria:

“Minimum 1000 Acres of land or more at single location and within 10-20 KMs from any existing 220kV OR 400kV STU/CTU Substation”

However, preference shall be given to Land Banks/Parcel on the basis of distance to Substation, availability of Land Bank as a single connected patch, water availability, topography, Forest land, Village/Govt roads within land bank. Transmission lines within land bank, wildlife protected areas, infrastructure i.e. road connectivity, Global Horizontal Irradiance (GHI) etc. There should not be any government restriction in setting up of Solar Power Project in the Land Bank/Parcel. There is no specific format for EOI submission, the interested applicant may submit their proposal along with Jamabandi of land and relevant documents, mentioning Land Lease Rent in case of leasing OR land cost in case of outright sale (Rs./Acre).

The proposal from interested parties shall be submitted to this office within 07 Days from the date of publication of this EOI either in Hard Copy or through e-mail at sjvncontractdelhi@gmail.com.
