ELIGIBILITY CONDITIONS:

Specialized firms/contractors who fulfill the following requirements shall be eligible to apply. Joint ventures are not accepted.

2 (i) Financial

The Firm should have Average annual financial turnover of at least 100% of the estimated cost during the immediate last 3 consecutive financial years.

(ii) Physical

The firm should have satisfactorily completed the similar works with Central/State Govt. Departments/ Central/ State

PSUs during the last 7 years ending last day of the month previous to the one in which tenders are invited as follows-Three similar works of Solar PV System, each of value not less than the amount equal to 40% of the estimated cost and with capacity being not less than 80% of the Solar PV system

OR

Two similar works of Solar PV System, each of value not less than the amount equal to 60% of the estimated cost and with capacity being not less than 80% of the Solar PV system

OR

One similar works of Solar PV System, each of value not less than the amount equal to 80% of the estimated cost and with capacity being not less than 80% of the Solar PV system in the last 7 years ending on the last day of the month previous to the one in which the tenders are invited.

Similar work shall means "ON Grid/OFF Grid/Hybrid Solar Power Pack work". The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of receipt of applications for tenders.

(iii) The firm should have valid GST registartion/Certificate of provisional registration for GST and copy of same is to be uploaded.

(iv) The firm will have to upload scanned copy of completion certificates of similar works of requisite magnitude issued by the officer of the client department of the rank of Executive Engineer or equivalent along with the bid. Works in which compensation is levied shall not be treated as satisfactory completion. If the work is completed beyond the stipulated date of completion then compensation levied or not levied should be mentioned in the completion report.

NOTE:-

- The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.

- 5 Those contractors not registered on the website mentioned above, are required to get registered beforehand.
- 6 The intending bidder must have valid digital signature of Class II or Class III Certificates with signing key usage to submit the bid
- The e-Tenders invited under two envelopes system, the first electronic envelope will be named as Technical Envelope & will contain documents of bidder's satisfying the eligibility conditions & tender documents and 2nd electronic envelope will be named as Financial Envelope containing Schedule/Bill of Quantities (BoQ). The bidder shall submit TECHNICAL BID ENVELOPE & FINANCIAL BID ENVELOPE simultaneously. The technical bids will be evaluated first and thereafter financial bids of eligible bidders only shall be opened. These envelopes shall contain one set of the following documents:-
