#### 3. SCOPE OF WORKS

The scope of Supply & Work includes Design, Engineering, Manufacturing, procurement & supply of equipment and materials, testing at manufacturers works, inspection, packing and forwarding, supply, receipt and unloading at site, site storage, preservation, safety and security of material, associated civil works, services, installation and incidentals. Insurance at all stages, erection, testing and commissioning of 400KWp Solar PV Power Plant including performance demonstration on turnkey basis & 02 (two) years non-comprehensive plant maintenance with spares after 01 (One) year of performance demonstration from the date of commissioning. The detailed Scope of Work has been outlined in the Technical specification (TS).

- **4.** To qualify for award of the Contract each bidder should have;
  - **A. Proven/ Technical Experience**: The Bidder should have experience of Supply, Installation, Testing & Commissioning of:-
    - a) One (01) No contract of Grid Connected Solar Photovoltaic Power Plants of
       320 kWp or above capacity.

OR

b) Two (02) Nos contracts of Grid Connected Solar Photovoltaic Power Plants of 200 kWp each or above capacity.

OR

c) Four (04) Nos contracts of Grid Connected Solar Photovoltaic Power Plants of 100 kWp each or above capacity.

The agency should have supplied and commissioned the similar Contracts\* plants mentioned above during a period of past 7 (seven) years reckoned from date of issuance of NIT.

\*Similar contracts means "Supply, Installation, Testing & Commissioning of Solar Photovoltaic Power Plant".

In support of above, Bidder shall submit the followings from Clients/Owners:-

- a) Copy of LOAs/ Work Orders/ Agreements.
- b) Commissioning Report/Work Completion Certificate along with Successful Operation certificate.

**Note:** Experience certificate and work order from employer should be submitted along with the bid to substantiate experience in all cases. In case evidence of work experience against QR is issued by non-governmental organization; copy of TDS/26AS/Form 16A issued by employer against the said work is required to be submitted by the bidder.

B. Financial Requirement: The Bidder must have an average annual financial turnover of INR 81, 82,770/- (INR Eighty One Lakhs Eighty Two Thousands Seven Hundred Seventy only) during last three years ending 31<sup>st</sup> March of previous financial year.

In support of above, reports on the financial standing, such as balance sheets, profit and loss statements and auditor's reports for the past three financial years shall be submitted by the Bidder along-with their Bid Proposal.

- **C.** The bidder must possess Valid PAN Card, EPF Code Number, GST Registration Number & duly authenticated copies of the same are to be furnished by the bidder along-with their Bid Proposal.

5.2 <u>DIGITAL</u> SIGNATURES: For participating in E-tendering i.e for login, uploading & downloading the Tender document or for submitting the Bid on E-mode, the bidder has to procure a Digital Signature/Digital Security Certificate. If any Bidder withdraws his bid before the said period or makes any modifications in the terms and conditions of the bid, the Employer shall forfeit the said Earnest Money/Bid Security.

#### 9. BID SUBMISSION:

(A) The tender in two bids (in three Part) system shall comprise of three parts in the following manner:

#### (a) Technical Bid:

Part I - EMD and Cost of tender Document.

- (iii) If the bidder quotes 'Nil' Charges / consideration, the bid shall be treated as unresponsive and will not be considered.

- **(B)** The SJVN Limited shall evaluate the qualifying requirements of each bidder as per NIT after opening of bids i.e. techno-commercial part of the bid. The bids of the bidder who is not meeting the qualifying requirements shall be treated as non-responsive.

### 10. BID OPENING:

The bid shall be opened in the following sequence:

- **11.** The above mentioned requirements are minimum and the SJVN Limited, reserves the right to ask for any additional information.
- 12. Notwithstanding anything stated above, SJVN Limited reserves the right to assess the capabilities and capacity of the Contractors/Company/Firm to perform the contract satisfactorily, should the circumstances warrant such assessment in the overall interest of the SJVN Limited.
- **13.** The bids in physical form / conditional / facsimile tenders shall not be entertained under any circumstances. The bids are only to be submitted through e-tendering; however document required at **Sr. No. 7.2** to be submitted in physical form as well as through e-tendering mode also.

#### 15. CORRECTION OF ERRORS (APPLICABLE TO EXTENT POSSIBLE).

The prices are to be filled in Online Dynamic Schedules as under:

- **B.** The entered Unit Rates in figures shall be automatically converted in to the words.
- **C.** The above entered Unit Rates in the figures shall be automatically multiplied with quantity to calculate the Total Amount in figures.

#### 17. PAYMENT PROCEDURE:

I. In case of Micro & Small Enterprise (MSE)

All the payments for the supplies and / or services (as applicable) rendered by MSEs (Micro & Small Enterprises) supplier / contractor under the contract shall be released within forty five (45) days from the day of acceptance, subject to submission of invoice on or before the day of acceptance.

Day of acceptance means day of actual delivery of goods or the rendering of services; or where any objection is made in writing by SJVN regarding acceptance of goods or services within fifteen days from the date of delivery of goods or the rendering of services, the day on which such objection is removed by the contractor / supplier. In case payments are not released as mentioned above, SJVN shall pay the principal amount plus compound interest with monthly rests from the date immediately following the date agreed upon @ three times of bank rates as notified by Reserve Bank of India from time to time.

#### II. In case of non-MSE:
