	(iv) In case of applications/bids from unenlisted contractors, where scanned copies of requisite DD/Bankers Cheque towards cost of tender has been uploaded but physical copies are not received by the stipulated date, finance bids will not be opened. Name of such contractors alongwith complete address shall be circulated for not opening of their bids for a period of six months commencing from the date of opening of finance bid.
	(v) In case of applications/bids (enlisted contractor as well as unenlisted contractor) where scanned copies of requisite Earnest Money (as applicable) were uploaded but the same are not received in physical form within stipulated time, such bids shall not qualify for opening of finance bid.

	(ii) Solvency certificate and working capital certificate issued by Scheduled Bank.
	(iii) Annual turnover certificate for last 2 years issued by Chartered Accountant alongwith relevant pages of audited balance sheets in support thereof.
	(iv) Affidavits for possession of movable & immovable properties by proprietor/partner owing the immovable property alongwith Valuation Certificate from Regd Valuer in support of movable & immovable properties. In case of Limited Company, the immovable property is required to be in the name of the company. In case of Limited Company, the immovable property is required to be in the name of the Company.

Within 28 days of receipt of Letter of Acceptance, the successful contractor shall submit to the Accepting Officer a Performance Security Deposit for an amount equivalent to 05% (Five percent) of the Contract sum in the form of Bank Guarantee in the prescribed form of Nationalized/Scheduled Indian Bank or Government Securities or FDR or any other Government instruments as directed by the Accepting Officer. Mix of forms of Performance Security Deposit for the same contract shall not be allowed. The performance Security Deposit shall be kept valid till expiry of defects liability period. Failure of the successful contractor to submit Performance Security Deposit within the prescribed time shall constitute sufficient ground for cancellation of award of work and forfeiture of the Earnest Money.</p>
<p>(h) <b><u>DEFECT LIABILITY PERIOD</u></b> In term of condition 46 of IAFW-2249 (as amended vide amendment No 48), defect liability period in respect of this tender shall be 24 months.</p>
