Sealed Tenders are invited for the supply of goods given in the Schedule below. The amount quoted shall be for delivery of goods at the site shown in the table. Tender received late, Tender, without specifying firm period, Tender with price variation clauses and incomplete Tender will not be accepted. Maximum number of days for delivery of good should invariably be stated in the Tender.

Conditions for acceptance of Tenders:

1. All the Bids and Specifications submitted should be evaluated by experts before final acceptance of the tender

- 2. Successful Tenderer shall enter into a contract at his own expense with the officer noted above within 5 days of receipt of communication confirming the Tenders.
- 3. Security Deposit being 5% of the contract amount shall be remitted before entering into the contract.
- 4. Withdrawing from Tender when required to sign the contract, refusing to sign the contract with in the appointed date, make delivery violating specifications and deliver substandard materials etc, will entitle cancellation of the Tender and purchasing the goods at the risk and cost of the Tenderer. Any loss sustained due to such purchases shall be recovered from the Tenderer. Besides he will be blacklisted and the same will be reported to the District Collector and Stores Purchase Department for further action.
- 5. In cases where samples are to be submitted the list of samples shall be submitted in a separate sealed cover along with the Tender. Samples are to be submitted directly at the expense of the Tenderer. Local Government may return or not return the sample at its discretion.
- 6. Contractor or Supplier should submit GST details, experience certificate, qualification, proof regarding license along with tender application.
- 7. Contractor should obey the directions from the panchayat regarding the work.
- 8. After confirmation of the Tender any demand for increase in price will not be accepted.
- 9. Any unlawful interference for acceptance of Tender will be a disqualification.
- 10. If any permission or license from any authority is required for using the goods delivered it should be (including the authority) clearly stated in the Tender.
- 11. In the case of machinery the firm shall give its user specifications, safety measures and precautions to be taken while effecting supply.
- 12. Tender shall be submitted for all or any of the items shown in the table. But for a particular item the whole quantity shall be quoted.

- 13. If the supply of the goods is partially made and fails to supply the balance in time the undelivered portion shall be purchased at the risk and cost of the Tenderer and any loss thereof will be recovered from the contractor. In such cases payment for partial supply shall be made only after the completion of the process.
- 14. The amount quoted should be inclusive of all taxes, duties, cess, packing and transportation charges and installation and commissioning charges (Wherever applicable)
- 15. Payment shall be made within fifteen days after examination by the Procurement Officer and taking into stocks. In the case of machinery and equipments payment will be made after certifying that the machines are functional. The responsibility to obtain the certificate from the concerned authorities rests with the supplier.
- 16. In the case of goods having guarantee/warrantee, security deposit will be returned after the guarantee/warrantee period. In case of any complaint decision on refund will be taken after considering the complaints.
- 17. If any rebate is available for speedy (eg. 7 days/10 days) payment the same can be shown in the Tenders)
- 18. LSGI will be free to adjust any amount due from the supplier from the cost of the goods supplied.
- 19. The officer entering in to the contract will have the right to include any condition not contrary to the provisions in the purchase manual in the contract.
- 20. LSGI reserves the right to reject any Tender without designing any reason.
- 21. Preliminary Agreement should submit along with the tender application (format attached)
- 22. Tender Cover as shown in Sl No 10 in E-Tender Notice should be submit on or before 28 October 2020 at 12.00 pm through post or by hand.
- 23. Further details are available from the office if requested in writing.
- 24. Bidders those whose are eligible for EMD / Tender Form Value Exemption should attach corresponding valued documents with the Tender
