

Notice Inviting Tender

- **Brief Description of the Bidding Process**
- **The Divisional General Manager (Divisional Office Nagpur)**, on behalf of **MEDA (the Employer)**, invites eligible bidder to submit a bid in accordance with the provisions of this Tender Document. In this Tender Document, the term "Bidder", which expression shall, unless repugnant to the context, include all parties who have submitted bids in response to this Tender Document within the stipulated time frame for submission.
- The Bidders shall submit the bids in two parts by following e-tendering process described in bidding documents. First part comprises of the technical bid and these Cond part comprise of the financial bid in accordance with this Tender Document.
