Orissa Hydro Power Corporation Ltd. (OHPC) having several hydro generation plants in the State has filed an application before this Commission for truing up of the Annual Revenue Requirement and Tariff of its Individual Power Stations from the financial year 1996-97 to 2015-16 in terms of S.62 & 86 of the Electricity Act, 2003 read with Clause 2.13 of the OERC (Terms & Conditions for Determination of Generation Tariff) Regulations, 2014. The Commission has registered it as Case No.55 of 2020 and has decided vide its interim order dated 10.11.2020 to dispose of this case through a public hearing which shall be held on 12.01.2021 at 11.00AM.
