ELIGIBILITY CONDITIONS:

1 The firms/contractors who fulfill the following requirements shall be eligible to apply. Joint ventures are not accepted.

2 (i) Financial

The Firm should have Average annual financial turnover of at least 50 % of the estimated cost during the immediate last 3 consecutive financial years.

(ii) Physical

The firms registered/ Enlisted in appropriate class in DOP/ BSNL/ CPWD/ Railways/ MES/ State PWD (B & R) or State Govt's Organizations dealing with building and roads.

OR

Specialized firms/contractors who have satisfactorily completed similar works with Central/State Govt. Departments/ Central/ State PSUs during the last 7 years ending last day of the month previous to the one in which tenders are invited as follows-

Three similar works of 10 kWp Solar PV System and each of value not less than the amount equal to 40% of the estimated cost.

OF

Two similar works of 10 kWp Solar PV System and each of value not less than the amount equal to 60% of the estimated cost.

OR

One similar work of 10 kWp Solar PV System and each of value not less than the amount equal to 80% of the estimated cost in the last 7 years ending on the last day of the month previous to the one in which the tenders are invited.

Similar work shall mean "SITC of ON Grid/ OFF Grid/ Hybrid Solar Power Pack work". The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of receipt of applications for tenders.

Works in which compensation is levied shall not be treated as satisfactory completion. If the work is completed beyond the stipulated date of completion then compensation levied or not levied should be mentioned in the completion report.

(iii) The firm should have valid GST registration/Certificate of provisional registration for GST and copy of same is to be uploaded.

 - 5. The intending bidder must have valid Class-III Digital Signature Certificates with signing & encryption key usage to submit the bid. Those contractors not registered on the website mentioned above, are required to get registered beforehand.
 - 6. The e-Tenders invited under two envelopes system, the first electronic envelope will be named as Technical Envelope & will contain documents of bidder's satisfying the eligibility conditions and tender document and 2nd electronic envelope will be named as Financial Envelope containing Bill of Quantities (BoQ). If the tender document is not uploaded, the bid shall be invalid and BOQ shall not be opened. The bidder shall submit TECHNICAL BID ENVELOPE & FINANCIAL BID ENVELOPE simultaneously. The technical bids will be evaluated first and thereafter financial bids of eligible bidders only shall be opened. These envelopes shall contain one set of the following documents:-
