P-2 INTSRUCTION TO BIDDERS

General guidance for e-Tendering for online submission of tenders annexed for participating in e-tendering.

- Registration of tenders: Any tenderer willing to participate in e-tendering will have to get himself enrolled and registered with the Government e-procurement system by login on www.wbtenders.nic.in. The tenderers are to click on the link for e-tendering site as given on the web portal.
- Digital Signature Certificate (DSC): For submission of tenders, each tenders is required to obtain a DSC from the
 approved service provider at the National Informatics Center (NIC) on payment of requisite amount, the details of which
 are available at the website.
- A tenderer can search & download NIT & tender documents electronically, the only mode of collection of tender documents from computers, once he logs on to the website using DSC.
- 4. Submission of Tenders:- Both the technical Bid and Financial Bid in two separate folders will have to be submitted online in the website at a time for each work within modified date & time using DSC and virus scanned and duly digitally signed copies of documents should be uploaded in the website. (These documents will get encrypted i.e., transformed in to non readable formats.)

N.B:- Original Copies of all documents are to be produced on demand for checking, otherwise tender will be rejected.

Financial COVER:

a. Only bill of quantity (BOQ). Intending tenderer is to quote this rate in Percentage, above or below / at per (in figure & word also) in space marked for quoting rate in BOQ through online.

General Terms and Conditions.

 Unless otherwise stipulated, all the works are to be done as per general qualification and any discrepancy in arithmetical calculation in BOQ should be brought to the notice of the Nirman Sahayak, Nowgan Gram Panchayat.

- Before quoting the rate in BOQ, the intending tenderers are requested to visit the site of work. No plea regarding enhancement of rate is entertained.
- The work must have to be completed in all respects within the stipulated time as mentioned in NIT. Time extension shall not be allowed without any reasonable ground.
- All materials should be approved by Engineer-in-Charge. Inferior quality of material, if found should be removed from the site within 24 hours by the contractor in his own cost.
- Payment will be made on the basis of successfully completion of work and availability of fund.
- Successful tenderer shall have to produce all documents in original for verification prior to issuance of work order.
- Before issuance of work order the successful tenderer shall have to make an agreement /contract in Non Judicial Stamp of worth Rs 10.00
- Conditional or incomplete tender will not be entertained.
- Deduction of Tax shall be followed as per Govt. Rule.
- 10. The tender inviting authority reserves the right to accept or reject any tender and to cancel the tendering process and reject all tenders at any time without assigning any reason.
- 11. The bidder whose bid has been accepted will be informed by tender inviting & accepting authority through acceptance letter.
- 12. All tender documents including NIT & B.O.Q will be the part of contract/agreement.
- 13. As per finance (Taxation) Department of Income Tax, Tax will be deducted from each bill of the contractor as per applicable rate in force.
- 14. Cess of 1.0% will be deducted from the contractor's each bill on account of the 'Building and other construction workers Welfare Act 1996(Act 28 of 1996).
- 15. Power of attorney holders are not allowed to sign in tender documents unless otherwise approved by tender inviting
- 16. The documents like, i. Draft of requisite amount against cost of Tender documents in favour Pradhan, Nowgan Gram Panchayat, (payable at Nowgan), ii Draft of requisite amount against Earnest Money Deposit (EMD) in favour Pradhan, Nowgan Gram Panchayat, (payable at Nowgan), and copy of other Non-Statutory Documents must be submitted physically within stipulated date & time.

One who does not submitted the documents; he will be disqualified in technical bid.

17. If it is proved that any bidder submitted false documents, security deposit may be forfeited or other disciplinary action as desired by this office may be imposed upon him.
