9. Any adverse measure on any account against the agency, who is working at present or worked during last five years, as on the date of bid, under any Govt. Dept and/ or recovery outstanding debarred/ black listed in any Govt. Dept. The filled in & duly signed form together with a separate sheet showing stage wise percentage breakup of the lump sum offer along with any addendum/corrigendum issued by the Dept. Duly signed by tenderer If the stage wise percentage break up of the Lump Sum offer of each Elevated progress by the Dept, the stage wise percentage break up given by the accepted authority of the Department shall be binding on the tender.

1. Bidder must must download NIT (Notice Inviting Tender), SOQ (Schedule of Quantity) & BOQ(Bill of Quantity) from the website www.wbtenders.gov.in and submitted in same website.(Offline submission will not be considered as a valid bid).
2. In the event of e-filling intending bidders may download the tender document from the website www.wbtenders.gov.in directly by the help of Digital Signature Certificate (DSC).
3. Cost of Tender Processing (non-refundable) has to be paid in MOTHFARAKA(FORM-5) in favour of **“Prodhan, BAGILA Gram Panchayat”** payable at Purba Bardhaman.
4. Bidders must submit attested photocopies of Company Pan card ,valid GST registration Certificate, last three years Income Tax Return, Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License from local bodies as the case may be ,Partnership deed if applicable,
5. Bidders must submit Credential in similar nature of work during last three years.
6. In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
7. Bidders must quote rate in BOQ(Bill of quantity) the estimated cost during online bid submission.
8. Rate offered by bidder in particular Tender shall be as final and subsequent negotiation with that bidder for change in price shall not be allowed.
9. Multiple bids(more than one bid by same bidder)& variable rates(different rates of same item by same bidder)shall be rejected outright.
