- 3- The contractors who fulfil the following requirement shall be eligible to apply.
 - (i) Should have successfully completed similar work works during the last seven years ending 31st march 2019, as a prime contractor satisfying either of the following.
 - (viii) One similar completed work costing not less than 80% of Tendered cost
 - (ix) Two similar completed work costing not less than 60% of Tendered cost.
 - (xiii) Three similar completed work each costing not less than 40% of Tendered cost.

Note:- One completed work of similar nature (either part of (i) or a separate one) costing not less than the amount equal to mentioned above of the estimated cost put to tender with some central Government Department / State Government Department/Central Autonomous Body/Central or State Public Sector Undertaking.
 - (xi) Should have an average annual financial turnover of 50% of estimated cost on construction work of similar nature during last three years. ending 31st march 2019 (copy of certificate from C.A. to be submitted)
 - (xii) Should not have incurred any loss in more than two years during the last five years. Solvency certificate form Banker of District Magistrate to be submitted.
 - (xiii) Information regarding projects in hand, current litigation, orders regarding exclusion, expulsion or black listing, if any should be indicated.
- 4- The bids shall remain valid for acceptance for a period of 90 days from the last date of submission of bids.
- 5- Bidders shall upload two separate covers marked "technical bid" and fee in PDF format and "financial bid" in cover "b" in Excel format.
- 6- Financial bids shall be opened of those bidder whose bids are technically qualified E.M.D. properly uploaded and found eligible. Scanned copy of E.M.D./Tender fee to be uploaded with technical bid.

- 9- Bid will be uploaded on e-tender portal of NIC on dates mention in section 'F' and the technical bids will be opened on ... at 03.00 P.M. in the office of Executive Engineer and the name of qualified bidders shall be uploaded to portal, the financial bids shall be opened on dated mention in section 'F' and name of successful bidder shall be uploaded and displayed.
- 10- Bid must be accompanied with tender fee of the amount specified for the work. The tender fee must be deposited online in bank account of U.P. State Construction and infrastructure Development Corporation Ltd. Payable at Prayagraj. The intending bidders has to upload the copy of Transaction detail on NIC Portal. - 11- Bids must be accompanied with earnest money of the amount specified for the work. The Earnest Money may be deposited in the form of RTGS of a Nationalized Bank/ Scheduled bank only payable at PRAYAGRAJ. The intending bidders has to fill all the details such as Bankers name, RTGS and Amount and Date of issue.
- 12- No Engineer of gazetted rank or other gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the state/Central Government is allowed to work as a contractor for a period of two years after his retirement from Government service, without Government permission. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government as aforesaid before submission of the tender or engagement in the contractor's services
- 13- Any bidder who is having criminal record is not allowed to participate in the bidding process.
- 14- Any bidder who is registered with the state Bar council is not allowed to participate in the bidding process.
- 15- Bidding Document general conditions of contract can be seen with tender document.
- 16- The successful bidder will have to submit 5% performance guarantee of the tendered cost in the form of bank guarantee RTGS of nationalized bank /Scheduled bank
If the rates quoted by the bidder is below the BOQ additional security will have to be deposited with reference to GO No. 622/23/12-2012-2 Audit/08T.C. -2 Dt. 08.06.2012 of UPPWD-Anubhag-12, as per following:-
- (c) 0.50% per 1.00% below up to 10%, below of BOQ.
- (f) 1.00% per 1.00% below, above 10% below of BOQ.
- Interested bidders can download the e-tender document & conditions form e-tender portal of Govt. Of Uttar Pradesh i.e. <https://etender.up.nic.in>. The Bid shall be submitted online using a valid Digital Signature Certificate. No other mode of submission is permitted. Bidders are advised to attend the pre-bid meeting.
- Note:- Any addendum or corrigendum or any other update shall be available on <https://etender.up.nic.in>. Therefore Bidders are requested to refer to the e-tender Portal from time to time for any addendum/corrigendum/other updated regarding the e-tender.
- 17- Two Bids cannot be submitted by single bidder. If at any stage it is found that one bidders wife is partner in other tender submitted then both the tenders shall be considered of same party and are liable to be rejected and their EMD will be forfeited.

- 18- Work Experience certificate shall only be submitted against single work order. Under no condition similar nature of work experience be clubbed and one experience certificate made shall not be considered as qualifying criteria for this work. Tender shall be rejected under said circumstances.

19- Compensation for Damages:-

It is understood that the Contractor shall remain liable to and shall indemnify the client and custodian in respect of losses, damages or compensation arising out of any accident or injury sustained by the client or by any workmen in the employment of the Contractor while in or upon the said work or the same arising out of any act, default or negligence, error in judgement on the part of PRW its employees or agents, subject to the determination of the compensation or damages by the competent authority as defined in the relevant law Besides it Penalty and other condition are mentioned below:-

- (g) In case of Non – completion of Project with in the time as determined by agreement from the date of starting the project penalty @0.1% per day of standard estimate shall be imposed which shall be payable by contractor concerned.
- (h) In case of non completion of work in stipulated period client (D.G. Medical Health services) may forfeit the centage charges payable to Nigam (as per agreement) the same amount shall be deducted from the bill of Contractor.
- (i) If the Contractor fails to start the construction of project according to provision of clause 2 of the Memorandum Contractor shall be liable to pay damages equivalent to 05% of the standard Estimate of the Project to Client.
