EXPRESSION OF INTEREST

National Institute of Wind Energy (NIWE), Chennai (Formerly Centre for Wind Energy Technology) is an autonomous Research & Development Institution under Ministry of New and Renewable Energy, Govt. of India.

NIWE is inviting submission of **Expression of Interest (EOI)** from Suitable, reputed and experienced Interested Parties for “**Finalizing the specification for Supply, Delivery, Civil Works, Installation, Commissioning and Maintenance of Solar Resource Assessment Stations with Albedo meter**” at Two locations in Ladakh region.

Scope of work is for Installation, Commissioning and Maintenance of Solar Resource Assessment Stations at two locations of Ladakh region. Supply and Delivery of related equipment and materials with Albedo meter including necessary Civil works at the specified locations required for setting up of Solar Stations as per the minimum technical requirements as specified in Annexure-I.

The Interested Bidders should submit and upload their EOI proposal in the CPP-Portal which is **due at 15.30 hrs on 03.12.2020**”. The proposals will be opened online **at 15.30hrs on 04.12.2020**. **All other documents relevant to the Expression of Interest wherever sought in the EOI document shall also be uploaded along with the proposal. Any Physical submission of documents shall be rejected summarily.**

NIWE’s Technical requirements, Eligibility criteria and other details for setting up the Solar Resource Stations are given at Annexure-I. This **EOI is of Non-Committal in nature** so that tender will not be restrictive in a later stage. As per the Government of India directives, only Indian bidders can participate in this Expression of Interest for which a tender will be floated in a later stage after finalizing the technical specifications.
