5. EMD/Bid Security (if submitted in BG form) shall be submitted in a sealed envelope separately offline by the stipulated bid submission closing date and time at the address given in Tender.

ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE EMD (BID SECURITY) / TENDER FEE (AS APPLICABLE) WITHIN STIPULATED BID SUBMISSION CLOSING DATE AND TIME SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE.

If benefits to MSE's is applicable, MSE vendors are required to upload the MSE certificate Online in Fee/EMD cover of tendering portal.

6. Notwithstanding anything stated above, the Employer reserves the right to assess the capabilities and capacity of the Bidder/ his collaborators / associates/ subsidiaries/ group companies to perform the contract, should the circumstances warrant such assessment in the overall interest of the Employer.
7. Employer reserves the right to reject any or all bids or cancel/withdraw the Invitation for Bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
8. A Complete Set of Tender Documents may be downloaded by any interested bidder free of cost through NTPC e-procurement portal, <http://eprocurementpc.nic.in>. For logging in to the e-tender website (GePNIC) and downloading Tender Documents, the bidder would require GePNIC User ID and Password, which can be created by registering at our e-tendering website (<http://eprocurementpc.nic.in>).

For access in GePNIC site, a valid Class III digital signature of the authorized person of the agency is a pre-requisite.

First time users not allotted any vendor code are required to approach NTPC at least three working days prior to last date of bid submission and submit following details:

9. Issuance of Bidding Documents to any Bidder shall not construe that such Bidder is considered to be qualified.

10. Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.

11. Preference to Make In India and granting of purchase preference to local suppliers

Only 'Class-I local suppliers' are eligible to participate in this tender, as defined in the bidding documents/ Public Procurement (Preference to Make in India), Order 2017 and its subsequent amendments/ revisions issued by DPIIT. The bidders may apprise themselves of the relevant provisions of bidding documents in this regard before submission of their bids.

Note: In this regard, the attention is invited to the format for CERTIFICATE FOR COMPLIANCE TO ALL PROVISIONS OF BIDDING DOCUMENTS provided in Forms & Procedures of Tender Documents, as such the acceptance of the above attribute shall also be considered as confirmation regarding bidder being Class-I local suppliers.

Complete details shall be as per the document "Preference to Make-In-India and granting of purchase preference to Local Suppliers" (The document is integral part of ITB-Instruction to Bidders)

12. BENEFITS TO MSEs

Micro and Small Enterprises (MSEs) registered with District Industries Centers or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts and Handloom or any other body specified by Ministry of Micro, Small and Medium Enterprises as per MSMED Act 2006, for goods produced and services rendered, shall be issued the bid documents free of cost and shall be exempted from paying Earnest Money Deposit.

Further, in case of tenders where splitting of quantity is possible, participating MSEs quoting price within price band of L1 + 15 percent shall also be allowed to supply a portion of requirement by bringing down their price to L1 price in a situation where L1 price is from someone other than a

Micro and Small Enterprise and such Micro and Small Enterprise shall be allowed to supply up to 20 percent of total tendered value. In case of more than one such MSE, the supply will be shared proportionately (to tendered quantity).

However, in case of tenders where splitting of quantity is not possible, participating MSEs quoting price within price band of L1 + 15 percent shall be allowed to execute the package by bringing down their price to L1 price in a situation where L1 price is from someone other than a Micro and Small Enterprise. The award shall be made as follows:

- a) Award shall be given to L1 bidder if L1 bidder is a MSE.
- b) In case L1 bidder is not a MSE, then all the MSE vendor(s) who have quoted within the range of L1 + 15%, shall be given the opportunity in order of their ranking (starting with the lowest quoted MSE bidder and so on) to bring down its price to match with L1 bidder. Award for full quantity shall be placed on the MSE vendor who matches its price with L1 Bidder at the price quoted by L1 bidder.
- c) If no MSE vendor who has quoted within range of L1 + 15% accepts the price of L1 bidder then the award shall be made to the L1 bidder.

The benefit as above to MSEs shall be available only for Goods/Services produced & provided by MSEs for which they are registered.

MSEs seeking exemption and benefits should enclose a attested/self-certified copy of registration certificate as a part of his bid, giving details such as stores/services, validity (if applicable) etc. failing which they run the risk of their bid being passed over as ineligible for the benefits applicable to MSEs.
