For & on behalf of President of India, the Director of Lighthouses & Lightships, Goa - India, invites Online Bids under two bid system (two cover system, Part I-Technical bid, Part II- Commercial bid) from the agencies registered as solar power business holder/Electrical Installation Companies for **Establishment of Off-Grid 5.5 KWp PV Solar System and Battery Banks at Kaup Lighthouse under DLL Goa.**

It is an essential requirement that the bidder has taken up, satisfactorily completed similar works, the value of 80% of Estimated cost for one work or 50% of Estimated cost each, for two works or 40% of Estimated cost, each for three works during last seven years ending 31st Jan, 2021.

		<p>The Similar works work shall mean supply and maintenance/after sale services in the field of supply and installation of standalone/ Off grid Solar PV / Grid tie solar PV systems.</p>
		<p>b. The Agency should be an authorized dealer or OEM of PV panels and either one of them should have experience of supply and maintenance/after sale services in the field of supply/installation of standalone/ Off / On grid Solar PV / Grid tie systems The bidder if agency or OEM must be registered channel partner with MNRE</p> <p>c. The bidder will preferably quote for OEM whose PV panels and PCU/Inverter should be of same manufacturer to ensure compatibility with subsystem.</p>

- 1.1 Tender Fee of 500/- in the form of Demand Draft (in original) drawn in favour of “Director of Lighthouses and Lightships”, Payable at Goa.
- 1.2 EMD of Rs 41480/- shall be furnished in the form of Demand Draft FDR from any Nationalized Bank, drawn in favour of the Director of Lighthouses and Lightships. EMD in any other form shall not be accepted. Detail of submission of EMD given in Annexure -I
- 1.3 Submission of EMD and Tender Fees will be as per above schedule.
- 1.4 The details of work are available in the tender document which can be downloaded from website Central Public Procurement (CPP) Portal <http://eprocure.gov.in/eprocure/app> and the bid is to be submitted online only on <http://eprocure.gov.in/eprocure/app> up to last date and time of submission of tender.
- 1.5 Bidding is open to all eligible Bidders meeting the eligibility criteria as defined in clause 3.1. Bidders are to note and satisfy themselves that they fulfill eligibility criteria.
- 1.6 Technical evaluation shall be carried out by a Committee. On completion of technical evaluation only, the Commercial Bids shall be opened by the Committee. It is an essential requirement to obtain 80% in the technical bid to qualify for opening of commercial bid. Commercial bids of those bidders who do not score 80% in technical bids shall not be opened. The decision of the Director, Goain deciding the successful bidder shall be final and binding on the bidders.
- 1.7 The Bidder shall carefully read Eligibility Criteria & instructions to Bidders, Technical requirement & Scope of work, General & Special conditions of contract, all other documents in connection with the Bid. The Bidder shall quote his rates, keeping all above points in mind.
- 1.8 The bid comprises of **Establishment of Off-Grid 5.5 KWp PV Solar System and Battery Banks at Kaup Lighthouse under DLL Goa**. The DIRECTOR, GOA reserves to himself the right of accepting the bid. Bidder shall be bound to perform the same at the quoted rates.
- 1.9 Canvassing whether directly or indirectly, in connection with

Bid is strictly prohibited. The Bids submitted by the Bidders, who resort to canvassing, shall be summarily rejected.

1.10 Those Bidders whose near relatives are posted as accountant or as a Gazetted Officer in any capacity in the Directorate General of Lighthouses & Lightships shall not be permitted to Bid. The prospective Bidder shall also intimate the names of persons who are working with him in any capacity or subsequently employed by him, who are near relative to any gazetted officer in the DIRECTOR, GOA or in the Ministry of Ports, Shipping and Waterways. Any breach of this condition by the bidder shall render him ineligible. By the term 'near relative' is meant wife, husband, parents & grand parents, children & grand children, brothers & sisters, uncles, aunts & corresponding in laws.

1.11 The bidder shall disclose any payment made or proposed to be made to any intermediaries (agents etc) in connection with the bid.

1.12 No Gazetted Officer of Government of India, is allowed to work as a contractor without prior permission of the Govt. of India in writing to the competent authority for a period of two years after his retirement from government service. The contract is liable to be cancelled if either the contractor or any of his employee is found at any time to be such a person who had not obtained the permission of Govt. of India as aforesaid, before submission of the Bid or engagement in the contractor's service.

1.13 In the event of any specified date, being or declared as a holiday by the Government of India, the specified activities shall take place on or up to the appointed time on the next working day.

1.14 The Notice Inviting Bids shall form the part of contract document.
