E-Tender Notice

The bidders should submit their bids only if they consider themselves eligible and are in possession of all the requisite documents.

2. Pre-bid meeting will be held on **03.03.2021 at 1:00 PM** at office of General Manager, Ganga Pollution Prevention Unit, U.P. Jal Nigam, Varanasi.
3. Bidders can submit their bids online latest by **11.03.2021 up to 5PM**. Pre-qualification bid will be electronically opened on **12.03.2021 at 3:00PM** in presence of bidders or their representatives in office of General Manager, Ganga Pollution Prevention Unit, U.P. Jal Nigam, Varanasi.
4. The Bid should be valid for 120 days from the last date of submission of bids.
5. If the date of opening of technical bid happens to be a holiday, the bid shall be opened on the next working day at the same time **for which no separate communication shall be sent.**

6. Bidders having criminal record will not be allowed to participate in Bid process.
7. A person registered with any State Bar Council will not be eligible to participate in the Bid.
8. Joint Venture is allowed.
9. Contractors who inter alia fulfil the following requirements shall be eligible to apply.
Firm should have successfully completed and commissioned *similar works* during last Ten years from the date of publication of NIT, satisfying either of following: -
 - a) **Financial Experience**
 - i. Three similar completed and commissioned works each costing not less than **282.00 Lacs**
or
 - ii. Two similar completed and commissioned works costing not less than **188.00 Lacs**
or
 - iii. One similar completed and commissioned work costing not less than **141.00 Lacs**
 - b) **Physical Experience**
 - i. One similar completed work of solar power plant of capacity of minimum 480KW with Sub Station Work
or
 - ii. Two similar completed work of solar power plant of capacity of minimum 320 KW with Sub Station Work
or
 - iii. Three similar completed work of solar power plant of capacity of minimum 240 KW with Sub Station Work

This should be certified by an officer not below the rank of Executive Engineer/ Project Manager or equivalent. All the performance certificates submitted should be clear and exhaustive enough to establish similarity with the work under Bid. Ambiguous Performance Certificates will not be considered for evaluation.

- (c) Should have average annual financial turnover during immediate last three last 3 (three) consecutive financial years, equal to at least **141.00 Lacs**. Year in which no turnover is shown will also be considered for working out the average.
- (d) The bidder must have a positive net worth at the time of submission of bid, contractor has to upload **Certificate from Statutory Auditor of the firm mentioning year wise financial turnover on construction works** of last 5 years. Further details, if required, maybe asked from the contractor after opening of technical bids.
- (e) The applicant should submit Income tax clearance certificate of last 3 years.
- (f) Solvency certificate of minimum **188.00Lacs** will be required to be submitted.
 - Solvency certificate issued by any scheduled commercial bank of India shall be accepted, which will be valid for a period of one year from the date of issue unless otherwise mentioned.
or
 - Solvency certificate issued by District Magistrate will also be accepted which will have a validity of one year from date of issue unless otherwise mentioned.
10. This NIT and other information/corrigenda/addenda and Instruction for bidders posted on website shall form part of bid document.
11. The quantities given in the Bill of Quantities are estimated and provisional and are given to provide a common basis for bidding. These are liable to change up to any extent for which no claim except as provided under contract shall be admitted.
12. The bid document consisting of Technical (eligibility) bid & financial bids including specifications, the bills of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and another necessary document are available on "<https://e-tender.up.nic.in>".

12. The technical bid shall be opened first on due date and time as mentioned above. The time and date of opening of financial bid of contractors, qualifying the technical bid shall be communicated to them on a later date through portal.
13. If the Bidder feels that technical credentials of his own or other Bidders have been wrongly evaluated/verified, he may raise **objections within 2 (two) working days** from the date of uploading of result. No requests/objections shall be entertained beyond above limit, else it may be treated as an obstruction in tender process and shall be dealt with accordingly.
14. The department reserves the right to reject any prospective application or to cancel entire bid process without assigning any reason whatsoever.
15. The Cost of the tender Rs. 10,000.00 + 18% G.S.T. charges (non-reimbursable) shall be paid through only **NEFT/R.T.G.S** in the **Account of Executive Engineer, Jal Nigam Yantrik Khand-II, U.P. Jal Nigam, Varanasi S.B. Account No1868000100039721 of Punjab National Bank, Mahmoorganj, Varanasi IFSC Code-PUNB0186800**. No Interest will be paid on earnest money.
16. **Earnest Money Deposit (EMD):**

The bid security Earnest Money Deposit should be paid **through NEFT/R.T.G.S in the Account of Executive Engineer, Jal Nigam Yantrik Khand-II, U.P. Jal Nigam, Varanasi S.B. Account No 1868000100039721 of Punjab National Bank, Mahmoorganj, Varanasi IFSC Code- PUNB0186800**. The Scanned copy of Earnest Money and Tender Document Fee Deposit shall be uploaded on the website. Bids without EMD shall not be entertained for Technical cum financial capability evaluation. No cash bid security will be asked for or accepted. In case of JV earnest money may be submitted by lead partner/JV.
17. The bid submission shall become invalid if:
 - i. The bidder is found ineligible.
 - ii. The bidder does not upload all the documents as stipulated in the bid document.
 - iii. If any discrepancy is noticed between uploaded documents and originals/hard copies submitted **later**.
 - iv. If subsequent to due date of submission of bid and/or after its submission bidder makes any further communication/ representation with the department with regard to the bid (whether technical or financial) than otherwise called for by the undersigned as a clarification.
 - v. If a bidder does not quote any percentage above/below on the total amount of the tender or any section/sub head in percentage rate tender. Then the tender will not be considered as lowest bid.
 - vi. Conditional tenders or Tenders without e-tender document fee & earnest money or invalid earnest money shall be summarily rejected.
18. The Bidder shall have to submit additional security/performance security with acceptance of Bid in compliance to MD letter no. **752/1009/072-0001/NIVIDA/PPRBD/20 dated 27/10/2020**, if the financial bid is found to be below norms as specified-

For >15% below BOQ amount @0.50% for every 1% below rates.
19. Intending Bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstance which may influence or affect their bid. A bidder shall be deemed to have full knowledge of the site, whether he inspects it or not, and no extra charge consequent to any misunderstanding or otherwise shall be allowed. The bidder shall be responsible for arranging and maintaining at his own cost all materials, tools & plans, water, electricity access, faculties for workers and all others services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a bid by a bidder implies that he has read this notice and all other contract documents and has made himself aware of the instructions, scope and specifications of the work to be done and local conditions and other factors having a bearing on the execution of the work.

20. Canvassing whether directly or indirectly, in connection with bids is strictly prohibited and the bids submitted by the bidders who resort to canvassing will be liable for rejection & will be debarred from future tender in U P Jal Nigam.
21. The bidder shall not be permitted to bid for works under supervisory control of Superintending Engineer and Executive Engineer concerned who is responsible for execution of work, in which his near relative is posted. He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any officer in the U P Jal Nigam. Any breach of this condition by the contractor would render him, if empanelled with U P Jal Nigam, liable to be removed from the approved list of contractors of U P Jal Nigam and make him liable for black listing.
22. No Engineer or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the STATE GOVERNMENT/State department Undertaking is allowed to work as a contractor for a period of two years after his retirement from Government service, without the prior permission of the Government of U.P. in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of U.P. as aforesaid before submission of the bid or engagement in the contractor's service.


