

- 1.2 The Bidder should have carried out Third Party inspection, in line quality checks of PV modules–for cumulative capacity of minimum 400MWp in last three years ending last day of month previous to the date of submission of bid.
- 1.3 The Bidder should have carried out Third Party inspection, in line quality checks of at least 100MWp in a single order for a Single Module Manufacturer in last three years ending last day of month previous to the date of submission of bid.






