NTPC invites **online bids** on **Single Stage Two Envelope bidding basis**(Envelope-I: Techno-Commercial Bid & Envelope-II: Price Bid) from eligible bidders for **Proposal Design, Engineering, Supply, Installation, Testing and Commissioning with performance test of the Solar Panel (200kWp) to be installed on CW Channel at NTPC Dadri** per the Scope of Work mentioned hereinafter.

1.0 BRIEF SCOPE OF WORK

The scope of work includes the “**Design, Engineering, Supply, Installation, Testing and Commissioning with performance test of the Solar Panel (200kWp) to be installed on CW Channel at NTPC Dadri**” as per approved drawing, technical specifications and as per direction of EIC. The agency should visit the site before quoting his rate to understand the actual site situation, nature of job, local surroundings etc.

3.0 Employer intends to finance the subject package through internal resources.

5.0 Tender Fee shall be submitted **ONLY Through online e-Procurement portal** by the stipulated bid submission closing date and time at the address given below.

ANY BID NOT ACCOMPANIED BY AN ACCEPTABLE "BID SECURITY DECLARATION" IN ONLINE ATTRIBUTES (GTEs) SHALL BE REJECTED BY THE EMPLOYER AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED.

6.0 Qualification Requirements for Bidders:

"Design, Engineering, Supply, Installation, Testing and Commissioning with performance test of the Solar Panel (200kWp) to be installed on CW Channel at NTPC Dadri."

1. Technical Criteria (Similar Work):

The bidder should have successfully executed works of supply, erection and commissioning of solar Solar Photo Voltaic (SPV) based grid connected power plant(s) of installed capacity of 160 kWp or higher at a single location. The afore-mentioned plant must have been in successful operation for at least six (6) months prior to the date of techno-commercial bid opening.

2. Financial Criteria of Bidder

1. The average annual financial turnover of the bidder during the last three (03) financial years as on the date of Techno-commercial bid opening should not be less than Rs. 142.86 lakhs (One Hundred forty-two lakhs and eighty-six thousand only)
2. The bidder should have successfully executed any one of the following "Similar Work" during the preceding seven (07) years as on the date of Techno-commercial bid opening:

- Single (01) order of contract value not less than Rs. 114.28 Rs. lakhs.
Or
- Two (02) orders, each of contract value not less than Rs. 71.43 lakhs.
Or
- Three (03) orders, each of contact value not less than Rs. 57.14 lakhs.

3. The word “executed” mentioned above means the bidder should have achieved the above-mentioned financial criteria (B.2), even if the total contract is started earlier and / or is not completed/closed.

4. In case where audited results for the last financial year as on the date of Techno-commercial bid opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case bidder is not able to submit the certificate from practicing Chartered accountant, certifying its financial parameters, the audited results of the three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on the date of Techno-commercial bid opening and the certificates from the practicing Chartered Accountant certifying the financial parameters are not available.

5. In case the bidder is not able to furnish it's audited financial statements on standalone entity basis, the un-audited unconsolidated financial statements of the bidder can be considered acceptable provided the bidder further furnishes the following documents for substantiation of its qualification.

a. Copies of the un-audited unconsolidated financial statements of the bidder along with copies of the audited consolidated financial statements of the holding company.

b. A certificate from the CEO/ CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the un-audited unconsolidated financial statements form part of the Consolidated Financial Statements of the Holding Company.

6. Other income shall not be considered for arriving at annual turnover.

7. The bidder should have a separate valid GST registration number and PAN Number.

8. Notwithstanding anything stated above, the Employer reserves the right to assess the capabilities and capacity of the Bidder/ his collaborators/ associates/ subsidiaries/group companies to perform the contract should the circumstances warrant such assessment in the overall interest of the Employer.

7.0 A Complete Set of Bidding Documents is available on NTPC e-tender site at <http://eprocurrentpc.nic.in>. Bidders are required to have GePNIC User ID and Password for downloading Tender Documents, by registering themselves on GePNIC Site (<http://eprocurrentpc.nic.in>). Tender documents can be downloaded by any interested bidder free of cost.

8.0 For access in GePNIC site, a valid Class III digital signature of the authorized person of the agency is a pre-requisite.

8.1 First time users not allotted any vendor code are required to approach NTPC at least three working days prior to last date of bid submission and submit following details:

8.2 Issuance of Bidding Documents to any Bidder shall not construe that such Bidder is considered qualified.

8.3 Transfer of Bidding Documents purchased by one intending Bidder to another is not permissible.

9.0 Preference to Make In India and granting of purchase preference to local suppliers

It is the policy of the Government of India to encourage 'Make in India' and promote manufacturing and production of Goods and Services in India with a view to enhancing income and employment. In this regard, the following guidelines, concerning the procedure to be adopted for granting Eligibilityfor Participation/purchase preference to local suppliers, are hereby issued:

NTPC shall allow purchase preference to bids from local suppliers as defined in the bidding documents. The bidders may apprise themselves of the relevant provisions of bidding documents

(Refer Annexure-I-ITB) in this regard before submission of their bids.

10.0 BENEFITS TO MSEs --NOT APPLICABLE—

11.0 Requirement of registration of bidder from a country, which shares a land border

with India: Any 'Bidder from a country which shares a land border with India', as specified in the Bidding Documents, will be eligible to bid in this tender only if bidder is registered with the Competent Authority as mentioned in the Bidding Documents. However, the said requirement of registration will not apply to bidders from those countries (even if sharing a land border with India) to which the Government of India has extended lines of credit or in which the Government of India is engaged in development projects.

12.0 Employer reserves the right to reject any or all bids or cancel/withdraw the Invitation for Bids without assigning any reason whatsoever and in such case no bidder / intending bidder shall have any claim arising out of such action.
