#### 18 SUBMISSION OF TENDER ITEM SAMPLES:

Bidders are requested to submit 3 (Three) nos. samples of tender item as per technical specifications and GTP along with adequate software in the form of CD and appropriate cables for down loading the data from meter to BCS. It is requested to submit complete flow chart details of software installation and meter data downloading procedures in hard copy with tender meter samples.

The samples are to be submitted to the Deputy Engineer (RSO), Regional Store Officer, Dudhsagar Road, Rajkot before due date and time of relevant documents physical submission. Samples are to be submitted along with the covering letter mentioning the serial nos. of tender item. Further during the process of opening and evaluation of the technical bid, if the box/container of the bidder sample does not contain the required nos. of tender samples, offer for that bidder will not be considered. Please note that samples of tender items are to be submitted strictly as per the tender technical specifications and GTP only.

Bidders are requested to note that testing of tender meter samples will be carried out at any third party Government Approved lab at ERDA, Vadodara or any other Government approved/NABL accredited laboratory decided by PGVCL.

Note that one representative of bidder will be allowed to witness testing at the laboratory for their sample only, who has requested in advance for witnessing tender sample testing. If bidder will not inform in advance regarding their willingness for witnessing of testing, bidder will not be allowed for witnessing of testing under any circumstances.

If a bidder wants to witness testing of tender item sample testing, the firm has to submit their request in advance (i.e. before opening of technical bid of the tender). In such cases, PGVCL will inform the bidder regarding testing schedule at the NABL accredited laboratory to remain present for witnessing testing of their tender sample on respective date and time. In case, a representative of bidder will not remain present for witnessing on scheduled date and time, then also test will be carryout out as per schedule only and no further correspondence in this regard will be entertained.

- 19 If required by the PGVCL, the successful tenderer has to lift poly carbonate material scrap of the meters of their make with all damages at their own risk, cost and responsibility on 'as & where' basis/condition lying at RSO/Division stores within two months from the receipt of letter from the Superintending Engineer of Circle office or from the Corporate Office intimating the address of the place/store for lifting of scrap.
  - The successful tenderer shall not have to make any payment to PGVCL for this poly carbonate material scrap & it is to be disposed of by them as per prevailing norms of the Government.

#### 22 Invitation of tender:

This tender is invited on behalf of PGVCL, MGVCL, DGVCL & UGVCL. After finalization of tender, Letter of Intent (LOI)/Price matching Letters shall be issued by PGVCL and after receipt of confirmation from bidders, the Master Letter of Acceptance (LOA) for allocation of quantity (DISCOM wise/Successful bidder wise) shall be issued by PGVCL. However, the respective DISCOM will issue LOA as per allocated quantity, prices and required delivery period for their DISCOM. Detailed purchase order will be issued by respective DISCOM after carrying out necessary formalities regarding submission of Security Deposit Bank Guarantee and Execution of purchase Agreement by the supplier as per tender terms and conditions. Bidders will have to abide all the terms and conditions of the LOI/LOA placed by PGVCL and final LOA and detailed purchase order placed by respective DISCOM.

#### 23 DELIVERY PERIOD:

In general, the delivery of total allocated quantity of each tender item against this tender shall be completed within 7 (Seven) months in equal monthly lots as decided by respective DISCOMs after a commencement period of 45 days from the date of receipt of Letter of Acceptance (LOA) of the respective DISCOM and as per clause no. 22 &23 etc. of tender commercial terms and conditions. However, if the any DISCOM requires earlier delivery; the same should be delivered as per their requirement.

Note that final delivery period shall be decided by each DISCOM as per their requirement and the delivery schedule will be given by respective DISCOM in their LOA & A/T.

The destinations for delivery shall be anywhere in Gujarat and shall be as specified in Purchase Order issued by respective DISCOMs.

Note that the supplier has to offer inspection call of equivalent quantity of monthly delivery schedule in every month in one time. If offered quantity for inspection will be less than the monthly delivery schedule, then the inspection call for inspection will not be considered.

If the quantity offered by the tenderer is reduced while placing the order, in that case delivery period quoted by the tenderer will also be reduced proportionately.

The successful bidder/s should have to submit / fulfill the following requirements within the commencement period of 45 days (from the date of LOA of respective DISCOM) to respective DISCOM. The delivery shall be reckoned after 45 days from the date of receipt of LOA of respective DISCOM.

- (1) The Bank Guarantee towards execution of contract (i.e. Security Deposit) must be invariably submitted within 15 (Fifteen) days from the date of LOA issued by respective DISCOM.
- (2) To execute Purchase Agreement at respective DISCOM, as per clause no.: 83 of tender terms and conditions of this tender, immediately on payments of Security deposit in respective DISCOM within 20 (Twenty) days from the date of LOA issued by respective DISCOM.
