7. M/s Daya Sugar, Gagalheri, Saharanpur quoted L-1 levelised tariff of Rs. 4.53/kWh and was declared successful bidder in line with the Clause 3.5.3 of RfP. The other four bidders were asked to match the levelised L-1 tariff in accordance with the Clause 3.5.5 of RfP. All the above four Bidders accepted the levelised L-1 rate of Rs. 4.53/kWh. The tariff schedule for levelised L-1 tariff is as per the table below:
