(h) This application is made in the full understanding that:

1. Through this EOI, NVVN intends to identify interested and capable parties for Lease/Purchase of land for setting up of solar power plants in the State of Maharashtra under scheme "Mukhyamantri Saur Krishi Vahini Yojna(MSKVY)". This EOI is not intended for empanelment of APPLICANT or pre-qualification of APPLICANT.
2. EOI process will be subject to verification of all information submitted at the discretion of NVVN.
3. NVVN reserves the right to reject/accept or partially accept any or all applications, cancel/withdraw the EOI process without assigning any reason whatsoever and in such case, APPLICANT shall not have any claim against NVVN arising out of such action.
4. The purpose of inviting this EOI is to identify the APPLICANTs through EOI who are interested in Leasing/sale of their land for setting up of solar power plants in the State of Maharashtra under the scheme "Mukhyamantri Saur Krishi Vahini Yojna(MSKVY)". Based on the outcome of Expression of Interest, NVVN will select the land of selected bidders at various locations for participating in the MSEDCL tender and will enter into necessary Agreement / MOU with the selected bidder/ land provider for participation in the tender issued/to be issued by MSEDCL under the scheme MSKVY. In case NVVN emerges as the successful bidder, NVVN shall either purchase the land or shall have the lease arrangement with the applicants. In case NVVN do not emerge as the successful bidder in the tendering process, then NVVN shall not purchase land/take land on lease from the applicant. In case NVVN emerge as a successful bidder , NVVN shall either purchase the land or shall have the lease arrangement with the applicants . Further there shall be no liability of NVVN, irrespective of the outcome of the Expression of Interest. Further the offer given by the applicant shall be valid till 180 days from the date of opening of bid/applications received in Eoi. In case any applicant, withdraw/or change its offer within 180 days from the date of opening of applicants received by Eoi, the applicant shall be blacklisted and shall be debarred in future tender/Eoi issued

by NVVN for 06 months from the date of withdrawal of offer by applicant. NVVN, at its own discretion may requests applicants to increase the validity of offer, beyond the said 180 days with same terms and conditions of the said EoI, the applicant(s) may/may not agree for extension of the said offer.
