2. At the outset, Shri R. Birthal, appearing for the Petitioner, submitted that an application (I.A. No. 6, dated 05.03.2021) has been filed by them seeking permission for withdrawal of the petition for amendment of Haryana Electricity Regulatory Commission (Terms and Conditions for determination of tariff for Renewable energy Sources, Renewable Purchase Obligation and Renewable energy Certificate) Regulations 2017 ('RE Regulations, 2017') notified on 24.07.2018 and Regulation No. HERC/40/2018/2nd Amendment/2019 notified on 14.06.2019.

The Commission observes that Haryana Electricity Regulatory Commission (Terms and Conditions for determination of Tariff from Renewable Energy Sources, Renewable Purchase Obligation and Renewable Energy Certificate) Regulations, 2021 (Regulation No. HERC/53/2021) have already been notified superseding the RE Regulations, 2017,

wherein the concern stated by the Petitioner has already been addressed. Since, the prayer of the Petitioner has already been adjudicated, nothing in this petition survives for the consideration of the Commission. The main petition is dismissed as infructuous. Accordingly, the present petition as well as I.A. filed in the matter is disposed of.
