# Order (Date of Hearing: 23.06.2021)

1. The last hearing in the matter was held on 10.06.2021 and the Commission Order was issued on 18.06.2021. The Petitioner (DIL) has submitted rejoinder to Shri Awasthi's Response.

The matter came up for the hearing today.

- 2. During the proceedings of the hearing, the Commission directed the Petitioner to submit certain additional information to be placed on record for Prudence Check of cost of additional coal with the Respondent (NPCL) and to Shri. R. S. Awasthi. The information to be submitted by the Petitioner are as below:
  - a. CIMFR Reports on Procurement of Additional Coal.
  - b. Invoice Copy from Suppliers for Additional Coal Purchased by the Petitioner.
  - c. S. K. Mitra Test Certificate Copies for the Coal received during each month of FY 2019-20.
  - d. Actual utilization of coal for supply of power to the Respondent.
- 3. Once the aforesaid information is received by the Petitioner, the Respondent and Shri. R.S. Awasthi to file a reply on it within 3 weeks' time and thereafter the Petitioner to file a rejoinder on it within 2 weeks' time.
