1. Item rate e-tenders are invited through the e-tendering portal by **Asst. General Manager (Engg.-Elect), AAI, Trichy International Airport, Trichy, Ph.No. 0431-2340551-554, EXT:352 (Bid manager)** on behalf of Chairman, AAI from the eligible contractors for the work of "Up Gradation of Passenger Terminal Building and Airside Facilities at Tiruchirappalli International Airport. S.H: Design, Supply, Installation, Testing and Commissioning of Roof Top Grid Connected 250kWp Solar Photo Voltaic (PV) Power Plant at Trichy Airport." at an estimated cost of Rs. 1,43,22,540/- (Excluding GST) (Rs. 1,15,43,602/- for SITC of 250kWp Solar Power Plant plus Rs.23,29,488/- for Operation and Rs.4,49,450/- for AICMC of SPP after Warrenty) with period of completion **180 Days for SITC and 07 (Seven) Years for Operation (after completion of work) and 02(Two) years for AICMC after 05 years warrenty period.**

- vii) Tenderer should deploy sufficient plant and machinery as per the requirement of work in consultation with the Engineer-In-Charge (EIC) to achieve the milestones / targets and overall completion within the time period. Tenderer shall submit scanned copy of 'Undertaking' Company's Letter Head.

viii) Companies other than propriety firm shall submit, scanned copy of Authorization Letter/Power of Attorney along with copy of Certificate of Incorporation of the Company under Companies Act showing CIN/LLPIN/Name of Directors of the Company & Copy of Board Resolution regarding Authority to assign Power of Attorney.

Proprietary firm shall submit scanned copy of Authorization Letter/Power of Attorney only if the tender is processed by a person other than proprietor.

ix) PQ Performa duly filled.

C. Qualifying requirements of Agencies / Tenderers containing the followings:-

Should have satisfactorily completed (# Phase/Part completion of the scope of work in a contract shall not be considered, **however pre-determined phasing of the work will be accepted**) three works, each of **Rs. 46,17,441.00** or two works, each of **Rs. 57,71,801.00** or one work of **Rs. 92,34,882.00** in single contract of similar nature of **“Supply, Installation, Testing and Commissioning of Roof Top / Ground Mounted Solar Plant of minimum 250kWp and above”** during last seven years ending on last date (extended date) of submission of bids.

Note: The experience certificates of works completed pre GST era, completion amount will be divided by 1.12 (to exclude pre GST tax of VAT 12%) to make it at par with experience certificates of post GST era but excluding GST

“The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of submission of bid”.

Client certificate for experience should show the nature of work done, the value of work, date of start, date of completion as per agreement, actual date of completion and satisfactory completion of work along with work order and Bill of Quantities. **Tenderers showing work experience certificate from non-government/non-PSU organizations should submit copy of tax deduction at sources (TDS) certificate along with a certificate issued by registered Chartered Accountant, clearly specifying the name of work, total payment received against the work and TDS amount for the work. (In case TDS is not available for supply portion, Tax invoice alongwith client receipt / certificate is to be submitted).**

i) Should have annualized average financial turnover of **Rs. 34,63,081.00** against works executed during last three years ending 31st March of the previous financial year. **As a proof, copy of Abridged Balance Sheet along with Profit and Loss Account Statement of the Tenderer should be submitted along with the application.** Tenderers showing continuous losses during the last three years in the balance sheet shall be summarily rejected.

ii) The tenderer should have a minimum net worth of **Rs. 17,31,540.00** issued by certified Chartered Accountants. **(as per Performa - I)**

Scanned copy of all the Documents of Envelope-I mentioned above shall be submitted on the CPP portal.
