Concept Note (Virtual Conference) Women In Renewable Energy and Sustainability

Renewable Energy is established as a "change enabler" when it comes to sustainability. India's energy and emission reduction targets necessitate a strong role of Renewable Energy in the country's developmental path in the future. MNRE truly feels that more programmes are required which focus on women working as leaders in the sector and especially in last mile energy enterprises. The Ministry wants to encourage mentoring and training of women in technical, marketing and business skills with a need to increasing their role and participation in RE sector.

MNRE takes this opportunity to open a consequential dialogue towards bringing more and more women to forefront and at leading positions in the Renewable Energy sector as well as impacting women's lives by making entrepreneurial opportunities available to them.
