**Record of Proceedings**

Case was called out for virtual hearing.

2. At the outset, learned counsel appearing for the Respondents, Chhattisgarh State Power Distribution Company Ltd. ('CSPDCL') and Chhattisgarh State Power Transmission Company Ltd. ('CSPTCL') sought time to file reply to the Petition. Learned counsel for the Petitioner had no objection in this regard.
3. Learned senior counsel for SECI submitted that SECI has already filed its reply.
4. Considering the submissions of learned counsels for the parties, the Commission directed the Respondents, CSPDCL and CSPTCL to file their respective reply within a week after serving copy to the Petitioner, who may file its
