Petition on account of occurrence of 'Change in Law' events as per Article 13.1.1 of the Power Purchase Agreement (PPA) dated 26.09.2014 between Noida Power Company Limited and Dhariwal Infrastructure Limited for claiming additional recurring/non-recurring expenditure incurred by Dhariwal Infrastructure Limited for the supply of 187 MW of Power (Net Capacity - 170 MW after excluding Normative Auxiliary Power Consumption) from Unit 2 of the Generating Station located at Taladi, Chandrapur, Maharashtra to Noida Power Company Limited.

- 3. Shri Divyanshu Bhatt, Counsel of Shri. R. S. Awasthi, Consumer Representative submitted that an impleadment application has been filed in the matter. The Commission asked the Petitioner for any objection on it, against which Ms. Mandakini Ghosh, Advocate, DIL submitted that the Petitioner has no objection. Awasthi to file their reply in the matter and thereafter one week time to the Petitioner to file rejoinder on it.
- 5. The Commission also directed the Petitioner and Shri. R. S. Awasthi to follow the timelines in filing the aforesaid replies and rejoinder in the matter for timely disposal.
