- 1. The instant Petition has been filed by M/s Superior Industries Ltd. (SIL) to allow export of 3.5 MW from its 5 MW biomass (i.e., rice husk) based generating plant to the Respondent in terms of PPA dated 13.02.2018 at tariff of Rs. 5.56 per unit till bidding process is not finalized.
- 2. The Prayers of the Petitioner is as below:
  - a) allow the Petitioner to export surplus power to the Respondent in terms of PPA dated 13.02.2018 at the Rate of Rs. 5.56/kWh till the bidding process is not finalized by the Respondents.
  - b) direct Respondent No.2 and 3 to schedule 3.5 MW Biomass based electricity from the Petitioner as per PPA dated 13.02.2018, and
  - c) any other suitable order as deemed fit and proper under the facts and circumstances of the case may be passed by this learned Commission.
- 3. During the hearing Sh. D. D. Chopra, the Petitioner's counsel requested the Commission to withdraw the present petition. The Commission asked the Advocate of the Respondents, Sh. Sh. Abhishek Kumar on the Petitioner's request. Sh. Abhishek Kumar responded that he has no objection on the withdrawal of the present petition.
- 4. After hearing the parties, the Commission allows the Petitioner's request to withdraw the present petition.

The Petition is disposed of in terms of the above.
