Online bids are invited on single stage two bid system for **SUPPLY, INSTALLATION AND COMMISSIONING OF SOLAR POWER GENERATOR/PLANTS OF 50 KVA PHOTOVOLTAIC (PV) AT HQ CE (P) SEWAK COMPLEX, DIMAPUR AND 10 KVA PHOTOVOLTAIC (PV) AT HQ 89 RCC (ZUBZA) NEAR KOHIMA WITH BATTERY BACKUP INCLUDING 05 (FIVE) YEARS COMPREHENSIVE WARRANTY AND MAINTENANCE IN THE STATE OF NAGALAND**

4. The work is estimated to cost **Rs. 84.50 Lacs (Rupees Eighty four Lakh Fifty Thousand Only)** Approximately or as subsequently amended in tender documents or uploaded in BRO website www.bro.gov.in and defproc website <https://defproc.gov.in/defproc/app> This estimate, however, is not a guarantee and is merely given as a rough guide and if works cost more or less, the tenderer shall have no claim on that account of what so ever nature.

5. The tender shall be based on drawings, specifications, quantity given in BOQ and General conditions of contract on IAFW 2249 and lump sum contract form based on IAFW-2159 with Schedule 'A' (list of works) to be priced by tenderers.

6. Not more than one tender shall be submitted by one contractor or contractors for one bridge having business relationship. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.

The completion period of work is **180 Days (ONE Hundred EIGHTY Days)** from the date of placing work order and **for phasing please see note 10 of Sch“A” notes** or as subsequently amended intender documents or uploaded in BRO website www.bro.gov.in and defproc website [https://defproc.gov.in/defproc/app_web_site_on accordance with the phasing ,if any, indicated](https://defproc.gov.in/defproc/app_web_site_on_accordance_with_the_phasing_if_any_indicated) in the tender from the date of handing over the site, which will be generally within one month from the date of issue of acceptance letter.

8. The Chief Engineer Project Sewak, C/O 99 APO will be the **Accepting Officer**, here in after, referred to as such for the purpose of this contract.

9. In tending tenderers are advised to visit again BRO website www.bro.gov.in (for reference only) and defproc website [https://defproc.gov.in/defproc/app 03](https://defproc.gov.in/defproc/app_03) (three) days prior to date of submission of tender for any corrigendum / addendum/amendment.

10. Earnest money is not required to be attached with tender by the contractor, but contractor has to furnish Bid Security Declaration (Amended vide GOI Min. of Finance OM No. F.9/4/2020-PPD dated 12 Nov 2020) as per format given in Special Condition of the tender document.

11. Successful Bidder (L-1) shall deposit to Accepting Officer a Performance Security for an amount of **3%** of contract sum (Amended vide GOI Min. of Finance OM No. F.9/4/2020-PPD dated 12 Nov 2020) in the shape of Bank Guarantee or FDR within 28 days of issue of LoA.

12. Copies of drawings (if applicable) and other documents pertaining to the work (signed for the purpose of identification by the Accepting Officer or his accredited representative) and sample of materials and stores to be supplied by the contractor will be opened for inspection at the following locations: -

17. The submission of a tender by a tenderer implies that he had read this notice and conditions of contract and has made himself aware of the scope and specifications of the work to be done and of the conditions and rates at which stores, tools and plants etc. will be issued to him, local conditions and other factors bearing on the execution of the work.
18. The Pre-Contract Integrity Pact has been signed by Accepting Officer or by the Officer specifically designated by him and scanned copy uploaded as part of NIT along with tender documents. Scanned copy of Integrity Pact duly signed on each page by the bidder(s) shall be uploaded as part of technical bid (Cover-I) and original Integrity Pact duly signed on each page shall be forwarded by post along with EMD. Bidders who do not upload scanned copy of IP duly signed, shall be intimated of the same along with intimation of other such deficient documents, through option of 'Short Fall Documents' (in e-tendering portal) before 'T' Bid evaluation. Any bidder who fails to forward the copy of IP duly signed even after this communication, shall be disqualified in the Technical Bid (Cover-I)".
19. The hard copy of original instruments in respect of cost of Earnest Money Deposit, original copy of affidavits and credit facility certificate must be delivered to the Chief Engineer Project SEWAK, C/O 99 APO on or before bid opening date/ time as mentioned in critical date sheet. Tenderer shall likely to be liable for legal action for non- submission of original payment instrument like Demand Draft etc., against the submitted bid. The Demand Draft attached/submitted for tender fee shall be nonrefundable
20. The Accepting Officer does not bind himself to accept the lowest or any tender or to give any reasons for not doing so.
21. Tender may be accepted in parts or as a whole. The bidder will not have any claim on this account and the decision of Accepting Officer shall be final and binding
22. In case of applications/bids (enlisted contractor/ as well as un-enlisted contractors) where scanned copies of requisite Earnest money (as applicable) were uploaded but the same are not received in physical form within stipulated time, such bids shall not qualify for opening of finance bid.
23. In case of rejection of technical bid , contractor may appeal to next higher Engineering Authority Addl Director General, Border Road (East),PIN.900 885, C/o 99 APO on email bro-adqbr.east@bro.gov.in against rejection whose decision shall be final and binding , However , contractor/ bidder shall not be entitled for any compensation what so ever on account of rejection of technical bid.

In the event of lowest tenderer revoking his offer or revising his rates upward (which will be treated as revocation of offer), after opening of tenders, the earnest money deposited by him shall be forfeited. In case of BRO enlisted contractors, the amount equal to the earnest money stipulated in the Notice of tender, shall be notified to the tenderer for depositing the amount through MRO, failing which the amount shall be recovered from payment due to such contractor or shall be adjusted from the Standing Security Deposit. In addition, such tenderer and his related firm shall not be allowed to participate in the tendering in second call or subsequent calls.
