## **Record of Proceedings**

Case was called out for virtual hearing.

2. Learned senior counsel for the Petitioner submitted that the instant petition may be taken up for hearing along with Petition No. 610/MP/2020, which is listed for hearing on 17.9.2021, as the issues involved are similar. The learned senior counsel also requested for time to place on record compilation of documents which are relevant for adjudication of matter.

3. Learned counsel appearing on behalf of NTPC submitted that Petition No. 610/MP/2020 is based on Tariff Based Competitive Bidding ('TBCB') under Section 63 of the Electricity Act, 2003 ("Act"). Therefore, instant petition may be dealt separately. In response, the learned senior counsel for the Petitioner clarified that the instant petition is also based on TBCB route under Section 63 of the Act.

4. The Commission directed to list the instant petition along with Petition No. 610/MP/2020 on 17.9.2021. The Commission permitted the Petitioner to file the compilation of documents and directed the Petitioner to file the following information on affidavit by 16.9.2021 with an advance copy to the Respondents:



- a. Legible copies of orders (With English translation, if required) of District Collectors regarding compensation for land.
- b. Element-wise claims under Change in Law and Force Majeure along with supporting documents pertaining to the claims.
- c. The billing details along with copies of bills post COD of Element 1, as Petitioner is claiming delay in making payments of Element 1 when Element 2 and Element 3 were under construction.

5. The Commission further directed the Petitioner to comply with the above direction within the specified timeline and observed that no further extension of time will be allowed.

6. The Petition shall be listed for hearing on 17.9.2021.
