CORRIGENDUM ORDER No. 1

- The Commission issued the Tariff Order for FY 2021-22 for State Owned Discoms dated July 29, 2021.
- Further, it is observed that the table for approval of the consolidated Power Purchase computed by the Commission for FY 2021-22 is inadvertently titled as "TABLE 6-26: GENERATING STATION-WISE POWER PURCHASE COST FOR FY 2020-21 APPROVED BY THE COMMISSION", whereas the same should be read as "TABLE 6-26: GENERATING STATION-WISE POWER PURCHASE COST FOR FY 2021-22 APPROVED BY THE COMMISSION".
- 3. Similarly, under the same table, the row heading 'k-IPP/JV' at S. No. 16 for Ghatampur TPS should be considered as deleted as the units of Ghatampur have still not achieved COD and accordingly, the rows "Sub-Total", "Total Long Term" and "Grand Total" will also stand revised as follows:
