Installation of solar power plant under RESCO model

Security Paper Mill (SPM), Hoshangabad, a unit of SPMCIL wholly owned by Govt. of India, Ministry of Finance, invites Expression of Interest (EOI) from the reputed firms for installation of a solar power plant with a recommended predefined capacity inside its premises under Renewable Energy Service Company (RESCO) model development program.

<b>(1) Scope of Work</b>	<p>SPM has been consistently endeavouring to operate in an environmentally responsible manner and has come up with a mission to undergo a development program meant to meet a part of its daily energy requirement through installation of a recommended predefined solar power plant under RESCO model in order to reduce its indirect GHG's emission to a minimum level and follow a kind of sustainable development approach.</p> <p>The following areas are intended to be covered :</p> <ol style="list-style-type: none"><li>1. The prospective bidders of RESCO provision will have to visit the SPM, Hoshangabad unit and will be exploring the solar potential in terms of its recommended installation capacity and appropriate mounting locations on the available land (approximately 23 acres) inside the premises out of which 8 acres may require land filling.</li><li>2. All kinds of land fillings and redevelopments, if any for the installation purposes, will be under the scope of bidders.</li><li>3. All kinds of maintenance activities in order to regulate the continuity of solar insulations, photo-voltaic power generations, inverters and batteries keep-ups will also be under the scope of bidders.</li><li>4. SPM will be using its required needed power and in case of surplus power generations and power during switch-off periods and plant shutdowns, the bidders may have to make an arrangement to supply the unused or surplus power outputs to some other consumers or to any grid for the effective harnessing and utilization of the solar power in</li></ol>
