INTRODUCTION:

Indian Oil Corporation Limited (IOCL), the largest commercial undertaking in India, is engaged in the business of refining, transportation and marketing the Petroleum products. IOCL, India's largest refining & marketing player is a Fortune "Global 500" company.

2. Category-I for Solar PV (SPV) Plants of Capacity above 50kWp and upto 500 kWp on All-India Basis

OBLIGATION OF EMPANELLED VENDORS/LSTK CONTRACTORS AFTER EMPANELMENT
