- 1.0 Karnataka Power Corporation Limited invites bids from the qualified bidders for the "Retrofitting, Design, engineering, supply, erection, testing & commissioning of 01 No. of LVRT compatible 1000kW inverter in place of existing 4 Nos. of 250kW Inverters at 3MW Yapaladinni Solar PV plant at Raichur Dist".
- **2.0** Pre-qualification criteria & bid documents may be downloaded from Government of Karnataka e-procurement website **https:/eproc.karnataka.gov.in** under login for contractors.
- 3.0 After login to Contractors, please scroll down to the right side bottom to see list of tenders, please click there to find the details of NIT & download copy of the tender. The tender can be downloaded from the portal as per prescribed date & time published in the portal. Only interested Contractors who wish to participate should remit on line transaction fee for tender after registering in the portal. The transaction fee is non-refundable.

4.0 SCOPE OF WORK:

Retrofitting, design, engineering, supply, erection, testing & commissioning of 01 No. of 1000kW LVRT compatible inverter in place of existing 4 Nos. of 250kW inverters.

The detailed scope includes:

- i. Dismantling of existing 4 Nos. of 250kW inverters of OPS make.
- ii. Installation of 1 No. of 1000kW capacity LVRT compatible inverter. The one 1000kW new Inverter shall be replaced in place of 04 Nos. existing 250 kW Inverters.
- iii. The existing LTAC panel, 1.25 MVA 11/0.415kV Transformer, Switchgear and cables shall be used.

5.0 EARNEST MONEY DEPOSIT (EMD)

As per GoK order dated 22.12.2020, the submission of EMD is exempted. However the bidder required to upload the declaration along with bid document.

6.0 Tenders (both Cover-I & II) must be electronically submitted (online through internet) within the date & time published in e-procurement portal. Cover-I of Tender will be opened at prescribed time & date in the e-procurement portal, in presence of the bidders who wish to attend at the office of the Executive Engineer (Solar), KPCL, # 3, Green Building, First Floor, Palace Road, Bengaluru - 560 001. Opening of Cover-II shall be intimated later.

Note: If a Govt. Holiday is declared on any of the above mentioned dates, next working day shall be considered. After evaluation of Pre-Qualification Bid (Cover-I), Price Bids (Cover-II) of Pre-qualified Bidders will be opened.

8.0 Eligibility Criteria:

- 8.1 The intending bidder shall satisfy the pre-qualification requirements as stipulated below:
 - i. Bidder should have successfully supplied & installed Power conditioning Units of 1000 kW capacity & above to any one Solar PV Power plants of MW scale in India and the same shall be in satisfactory operation continuously for a minimum period of 1 year during the preceding 5 years, from the date of issue of NIT with total Order value not less than Rs.20.25Lakhs. Satisfactory performance certificate issued from Competent Authority/State/Central Government undertaking/any utility from officers not below the rank of Executive Engineer/ equivalent cadre/ Project head of respective solar plant shall be furnished. The copy of the work order for corresponding works shall be furnished during tender evaluation if required.
 - ii. Bidder during the last five financial year period shall have achieved in at least two financial years an average annual turnover of Rs.40.50 Lakhs. As proof of the above, the audited balance sheet counter signed by Chartered accountant shall be furnished.
- 8.2 Those bidders whose EMDs are forfeited/contracts have been terminated/foreclosed by KPCL or elsewhere or whose performance has not been found satisfactory while executing contracts with KPCL or elsewhere during the last 05 years are not eligible to bid. The Bidder shall give declaration (Schedule-09 of the bid document) that EMD has not been forfeited & none of his contracts have been terminated /foreclosed on account of their default in KPCL or elsewhere during the last 05 years.
- 8.3 The intending bidder shall have the Income tax, PAN, GST Registration, ESI registration certificate, Provident Fund registration certificate (Independent PF Code). Copies shall be uploaded as documentary proof.
- **9.0** The tender is of two cover system.

The Bidder should upload scanned copies of the following documents:

A. COVER-I (Technical Bid)

- a) Documents to meet the qualification criteria specified in NIT.
- **b**) Details of the Commercial terms & conditions, all the schedules & annexures specified in bid documents pertaining to commercial terms & conditions.
- c) All the technical details etc., of the technical offer along with all the technical particulars.

B. COVER-II (Price Bid)

Price schedule only (Price Bid).

- **10.0** Bidder shall not be under declaration of ineligibility for corrupt & fraudulent practices issued by the Government of Karnataka.
- **11.0** Conditional Tenders will not be accepted.
- **12.0** The agency who receives the Work Orders from KPCL and thereafter if Work is not executed / not satisfactorily executed by them due to any reasons mentioned thereafter are not eligible for applying/participating in this tender.
- 13.0 Bids submitted within the scheduled date & time shall only be eligible for further processing of the bids. Any bid submitted after the date & time specified shall be rejected even if it is accepted by the e-portal. Date & time stamp of the e-portal system shall be final in deciding the time of submission of bid. Decision of the Corporation in this regard shall be final & acceptable to all the bidders.
- 14.0 The original documents should be produced for verification at any stage of tender process as and when sought for, failing which, the bids are liable for disqualification.
- 15.0 Rates shall be quoted in price schedule i.e. Price bid, in the e-procurement portal only. The bidder should not upload financial bid document separately in e-portal. If uploaded, the bidders are liable for rejection.
- 16.0 The bidder shall quote his rates inclusive of GST & other charges, PF, ESI as per the applicable rates as issued by the concerned departments from time to time.
- 17.0 KPCL shall recover the Income Tax, GST etc., at the prevailing applicable rates.
- **18.0** Price bid of bidders who have furnished all the documents to meet the qualification criteria, technically & commercially responsive will only be opened.
- **19.0** The tender shall be valid for 180 days from the date of opening of 'Cover-I' of the bid.
- **20.0** The bidder shall visit the KPCL 3MW Grid Connected Solar PV Plant at Yapaldinni Village at Raichur Dist. to understand the system before submitting the bids.
- **21.0** The tender document is part and parcel of the agreement.
- **22.0** The bidders should furnish a scanned copy the latest Income Tax returns.
- **23.0** KPCL reserves the right to verify any information/documents furnished by the bidder. In case the information or the documents furnished are found to be incorrect/false or invalid then the action shall be initiated against such bidder.

- **24.0** Corporation reserves the Right to reject any or all the tenders without assigning any reasons. However, in all cases KTPP act shall be followed.
- **25.0** Any other information required may be obtained from the office of the undersigned during office hours.
