2) Functions of the Samiti :

The Samiti shall advise the Ministry of New and Renewable Energy on matters relating to the progressive use of Hindi for official purposes.

3) Tenure of the Samiti :

The term of the Samiti will be three years from the date of its formation, provided that :

- (a) A Member of Parliament nominated to the Samiti shall cease to be a member of the Samiti as soon as he/she ceases to be a Member of Parliament;
- (b) Ex-officio members of the Samiti shall continue as members so long as they hold the office by virtue of which they are members of the Samiti; and
- (c) Members appointed against mid-term vacancies shall hold office only for the residual period of the three year's tenure.

4) General :

The Headquarters of the Samiti shall be at New Delhi and meetings of Samiti will be held in Delhi only.

5) T.A. and Other Allowances :

The Department of Official Language, Ministry of Home Affairs, Government of India, vide their Office Memorandum II/20034/04/2005-OL (Policy-2) dated 3rd February, 2006 has intimated that as the 15 non-official members include 6 Members of Parliament, nominated in the Hindi Salahakar Samitis constituted by Central Ministries/Departments, so the provision regarding travelling/daily allowances is made more elaborate in the following manner :-

- (a) The Members of Parliament nominated in the Samiti will be paid Travelling Allowance and Daily Allowance as per the provisions of the "Member of Parliament (Salary, Allowance and Pension) Act, 1954", as amended from time to time and rules made thereunder.
- (b) Travelling Allowance and Daily Allowance to other non-official members of the Samiti will be paid as per the guidelines contained in the Department of Official language O.M.No. II/22034/04/86-OL (A-2) dated 22nd January, 1987 and in accordance with the prescribed rates and rules as amended from time to time by the Government of India.

ORDER

It is Ordered that a copy of the Resolution be communicated to all the members of the Hindi Salahkar Samiti of the Ministry of New and Renewable Energy, all State Governments and Union Territory Administrations, President's Secretariat, Vice- President's Secretariat, Prime Minister's Office, Cabinet Secretariat., Ministry of Parliamentary Affairs, Lok Sabha Secretariat, Rajya Sabha Secretariat, Committee of Parliament on Official Language, NITI Aayog, Comptroller and Auditor General of India, Accountant General, Election Commission of India, Union Public Service Commission and all Ministries and Departments of the Govt. of India.
