ORDER

1. The present Petition has been filed under Section 86 (1) (b), (e), (k) and 86 (4) of the Electricity Act, 2003 read with Regulations 80, 84 of the GERC (Conduct of Business) Regulations, 2004 read with Regulation 12 of the Gujarat Electricity Regulatory Commission (Procurement of Energy from Renewable Sources)

Regulations 2010 by the Petitioners, seeking the following prayers as under:

- (a) To allow the present Petition to be listed for early/urgent hearing;
 - (b) To clarify, declare and hold that even if the Gujarat Wind Policy 2016 expires on 30.06.2021, the benefits and exemptions granted under the Wind Tariff Order shall continue till the validity of the said Order i.e., till 30.03.2022. The Wind Power Plants being established after the Wind Tariff Order shall remain eligible to receive the benefits granted in it, provided the same are commissioned with the control period stated therein;
 - (c) To grant such Order, further relief (s) in the facts and circumstances of the case as the Commission may deem just and equitable in favour of the Petitioner
2. Heard Ld. counsel appearing for the Petitioners. It is submitted that the Petitioners are not willing to pursue the present matter and want to withdraw the same and an affidavit for withdrawal will be filed shortly. Let the same will be filed by the Petitioners.
 3. Today i.e., on 16.10.2021, the Petitioner's Ld. Advocate has orally submitted that the Petitioners does not want to proceed further and requested to allow withdrawal. We record the statement of the Ld. Advocate and in view of it, this petition stands disposed of as withdrawn.
 4. We order accordingly.
