3. Qualifying Requirement:

- 3.1 **Financial Soundness:** The average annual turnover during last three financial years ending on **31st March 2020** should be at least 30% of the Estimated cost of the tender i.e. **Rs. 1.18 Lakhs.**

The bidder shall submit copy of Audited Balance sheet of the tender and profit & loss account for the last three financial years or certificate from chartered accountant with UDIN in respect of Annual Turnover for last three financial years ending **31st March 2020.**

- 3.2 The Bidder shall either be a manufacturer or Authorized representative of manufacturer. In case the bidder is an authorized representative of manufacturer, the valid authorization certificate (from OEM in the name of the bidder) to be submitted along with the offer.

Only agencies submitting a general Dealership or Authorization certificate issued by the Manufacturers, without reference to any specific tender and having validity of such authorization for the considerable duration shall only be considered for determining the eligibility criteria of the bidder for the particular tender. Authorization issued with reference to the specific tender in favour of particular dealer/bidder will not be entertained.

3.3 Experience:

Bidder should have received supply order(s)/purchase order(s) from any Govt. Deptt./Undertaking/PSU or reputed private companies for similar supply during the last two years ending last day of month previous to the one in which tenders are invited. Cumulative amount of these supply order (max. three SO/PO shall be considered) should not be less than 50% of estimated cost put to tender i.e. **Rs. 1.97 Lakhs.**

Similar supply means **“Supply & Installation of Solar PCU/Inverter”**

Bidder shall submit copy of Supply order(s) of requisite amount along with invoice or any other document showing the completion/proof of supply in support of experience.

- 3.4 Bidder must have valid GSTIN registration certificate.
- 3.5 Bidder must have valid Permanent Account Number (PAN).
- 4.0 The details/ information regarding online tendering i.e. Registration on CPP portal, Preparation of Bid and Submission of bid are available in the tender document. NHDC reserves the right to reject any or all tenders and shall not be bound to assign any reason for such rejection.
- 5.0 Micro and Small Enterprises (MSEs) Units registered with National Small Industries Corporation (NSIC) under their single point registration scheme for goods/services at NSIC or District Industries Centre (DIC) or Khadi and Village Industries Commission (KVIC) or Khadi Village and Industries Board (KVIB) or Coir Board or Directorate of Handicrafts and Handlooms or any other body specified by Ministry of MSME or MSEs having Udyam Registration Certificate (Please refer Note below) or Udyog Aadhar Memorandum are exempted from furnishing the ~~EMD and~~ tender fee. They should furnish a Notarized copy of valid registration certificate/ Entrepreneurs Memorandum (EM- II) details/ other relevant documents issued by above board/body in their favors, for goods/services covered under this tender document.

It is the sole responsibility of the bidder to ascertain whether registration certificate issued to him under MSME is applicable for the goods/ services covered under this tender document.
