b)This earnest money amount shall not carry any interest whatsoever. 2. Security Deposit: Total 2%

He should not quote his offer anywhere else directly or indirectly in Envelope No.1. The Contractor shall quote for the work as per details given in the main tender

C) Submission of Tender:

10. Opening of Tenders:
