- 9. - 10. The bid submitted shall become invalid if:-
 - (i) The bidders is found ineligible.

 - (iii) The bidder does not upload all the documents (including service tax registration/VAT Registration/Sales Tax Registration) as stipulated in the bid document including the copy of receipt for deposition or Original EMD)
 - (iv) If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted physically by the lowest bidder in the office of bid opening authority.
- 11. The Contractor whose tender is accepted will be required to furnish performance guarantee of 3% (Three percent) of the tendered amount within the period specified in Schedule F. GENERAL TERMS & CONDITIONS

- 1. The Schedule of work covers Operation & Running Maintenance of 1MWp Solar Photo Voltaic Power Plant complete with allied fixtures i/c cleaning of all fixtures i.e. switches & switching devices, panel etc. in all days except Sunday & Holidays at Thyagraj Stadium, Thyagraj Nagar, New Delhi.
- 2. The contractor has to provide services for day-to-day maintenance of 1MWp Solar Photo Voltaic Power Plant etc. in addition, the work should be carried out, as per CPWD Maintenance Manual 2019, Indian Electricity Act and rules, CPWD General Specification (Part –I 2013 for internal) Electrical work as applicable from time to time.
- 3. The work shall be carried out, as per direction of Engineer-in-charge or his authorized representative [Assistant Engineer (E) and Junior Engineer (E)].
- 4. The contractor shall intimate Engineer-in-charge or his authorized representative for any break down and shall arrange its rectification immediately to put the entire electrical installation, in operation again during the contract period.
- 5. The contractor shall provide complaint register, task register, worker diary, attendance register, soap, duster, broom, PVC tape, control cable, cleaning agents, old dhoti, badges and liveries etc for which nothing shall be paid extra.
- 6. No T&P shall be issued to the contractor. The contactor shall make his own arrangement of tools for maintenance of 1MWp Solar Photo Voltaic Power Plant /Sub Station/ Electrical Installations equipments & following T&P shall always be available at the site of work by the contractor:
 - a. Tong tester, Test lamp
 - b. Gloves 4 Sets.
 - c. First Aid Box
 - d. Crimping Tool Kit
 - e. Megar (5 KV HT & 500 volt LT)
 - f. Spanner Set.
 - g. Screw Driver set
 - h. LN Keys set
 - i. Earth Tester
 - j. Blower
 - k. Hammer, Drill Machine & Spade
 - 1. Every wireman/ operator should have pliers, screw driver of different size, tester & test lamp for day to day maintenance work.

Before start of contract these T&P materials must be kept in a lockable box, if same is not available at site recovery for the same @ Rs. 100/- per day shall be deduct from the contractor bill maximum up to Rs.1000/- per month.

- 7. The contractor shall maintain the proper discipline of operational and maintenance staff.
- 8. All equipments shall be handed over to the Department in good condition after completion of contract.
- 9. No staff below the age of 18 years should be employed on the work. The staff employed shall have good character. All staff on duty shall always wear uniforms with badges and keep cordial relation with client and other deployed staff.
- 10. All machineries, tools and plants shall be kept ready and same shall be inspected by the Engineer-in-Charge or his authorized representative at site.
- 11. If the contractor fails to provide services for operation & running Maintenance of entire 1MWp Solar Photo Voltaic Power Plant for a certain period due to absence of operating staff, recovery @ Rs. 150/- per hour for non operating period shall be made from his bill. In case of absence of staff and continuity of the services maintained by the existing shift operator, in absence of duty staff, than recovery shall be made @ Rs. 1446/- per shift for Wireman Cum Solar Technician & @Rs. 1192/- per shift for Khallasi.
- 12. No claim for absorption of staff in the department shall be entertained. The contractor has to indemnify the department in such eventuality.

- 13. After award of work the contractor will submit the details of operating staff for the work, their names, father's name, local address, qualifications and experience etc. to the Engineer-in-Charge or his authorized representative. In case of any change of operating staff is required by the contractor, the same shall be intimated to and got approved from the Engineer-in-charge or his authorized representative.
- 14. The contractor will ensure that no frequent replacement/removal of staff without the knowledge of Engineer-in-charge or his authorized representative shall be done. The Engineer-in-charge or his authorized representative reserve the right to ask the contractor to remove any of the operating staff, without assigning any reason, which so ever, the decision of Engineer-in-charge will be final and binding to the contractor.
- 15. During the running period of contract, the responsibilities of physical custody of entire electrical installations will rest on the contractor.
- 16. In case of any damage to the entire electrical & mechanical installations etc. on account of negligence of contractor's staff. The same will be made good by the contractor at his risk and cost. Failure to which the department will rectified the same and cost of the same shall be recovered from the contractor's bill.
- 17. After the expiry of the contract, the entire electrical & mechanical installations with complete inventory shall be handed over back to the department in similar condition, as was handed over to the contractor at the time of start of the contract, except normal wear and tear for which the contractor is not responsible, failing which recovery will be made from contractor's final bill. The decision of Engineer-in-charge or his authorized representative shall be final and binding.
- 18. All the complaints shall be attended promptly, after their registration. For this purpose, the contractor shall maintain a complaint register at site and further make arrangements to get complaints recorded in the complaint diaries of the Multi Tasking Staff. It will be the obligation on the part of Multi Tasking Staff to obtain the signatures from the caretaker/ in-charge of the premises in token of acceptance of satisfactorily attendance of their complaints. In case the contractor fails to attend the complaint within reasonable time, than recovery at the rate of Rs. 200/- per day will be effected.
- 19. Emergency complaints such as no current, leakage of current, sparks, short circuiting, fire hazards of any nature etc shall be attended immediately otherwise a recovery of Rs.500 per emergency complaint shall be made from the contractor's bill.
- 20.All material required for day to day maintenance will be issued to the contractor staff free of cost by the department & dismantled material will be have to return to the JE(E) in charge.
- 21. The deployed staffs of the contractor will liasoning with electrical power supply provider in case of failure of power supply.
- 22. The contract will commence from the date, as indicated in the letter of award. Department reserve the right to terminate the contract before the expiry of the contract period, without assigning any reason.
- 23. Department shall in no way be involved in any dispute of whatever kind, between the contractor and the staff engaged by him. The contractor shall be fully responsible to pay all the compensation and cover all the risks for the workers employed by him under workmen compensation act in the event of accident/death etc. The department will not be responsible in any way.
- 24. The contractor has to abide by the labour by laws, as amended upto date.
- 25. The contractor will depute well experienced technical qualified & professional staff whose qualification should be as under:

- 27. The contractor shall provide a mobile phone to the deployed staff for communicating with client department/AE(E)/JE(E) on own cost in case of urgency, in case of default, a sum of Rs. 100/- per default shall be deducted from contractor bills.
- 28. The contractor shall provide summer and winter uniforms provide on own cost to the deployed staff and the deployed staff shall attend the duty in proper uniform, otherwise Rs. 100/-per day per employee shall be deducted from the contractor bills.
- 29. The contractor or his authorized representative is required to visit site twice a week, so as to get acquainted with the difficulties of the site, if any and resolve them.
- 30. The contractor shall pay minimum wages as per Govt. of NCT of Delhi Minimum wages act amended up to date to his staff regularly up to 7th day of each month positively, failing which the penalty @ Rs.200/- Per day per employee shall be imposed, which will further be recovered from the running/final bill of the contractor.  - b. Copy of relevant period attendance register duly verified by JE (E)/ AE (E).

- 35. The ESI & EPF contributions on the part of employer in respect of this contract shall be paid by the contractor.
