- 2. Eligibility criteria for participating e-tender: The bidders shall have satisfactory completed as a prime agency during the last 5 years from the date of issue of this notice at least one work of similar nature under the authority of State/Central Govt., State/Central Govt. under taking, Statutory bodies constituted under the statute of the Central/ State Govt. and having a magnitude of 60% of the amount put tender. The completion certificate, Work Order copy and detail communicational address of the client must be indicated in the credential certificate.
