All above documents should be closed in Envelope No.1. If these documents are not complete, Envelope No.2 will not be opened.

B) EnvelopeNo.2(Financial)

The second Envelope No.2 The tenderer should quote his offer on BoQ of the tender as percentage of estimated rates at the appropriate place on tender documents, to be submitted only in Envelope No.2. He should not quote his offer anywhere else directly or indirectly in Envelope No.1. The Contractor shall quote for the work as per details given in the main tender

C) Submission of Tender:

13. Opening of Tenders:

The tenders will be opened online as per given schedule, in the office of Sarpanch/ Gramsevak Gram panchayat Office Bhare, Tq. Mulshi, Dist. Pune if possible, in presence of bidders or their authorized representatives, who choose to remain present. Following procedure will be adopted for opening of tenders.

EnvelopeNo.1

First of all, Envelope No.1 of the tender will be opened to verify its contents as per requirements. If the various documents contained in this envelope do not meet the requirements of the Sarpanch/ Gramsevak Gram panchayat Office Bhare, Tq. Mulshi, Dist. Pune, a note will be recorded accordingly by the tender opening authority, and the said tenderers Envelope No.2 will not be considered for further action, but the same will be recorded.

EnvelopeNo.2

After opening of Envelope No.1, if contents of Envelope No.1 are found to be acceptable to, then only this Envelope No.2 shall be opened immediately. The tendered rates in Schedule "B" (BoQ) as percentage above / below the estimated cost put to tender shall then be readout.

14. No Tender with arbitration clause will be considered.

15. Conditional Tender will be summarily rejected.

16. Right to modify the Tender Documents:
